- AN ACT to amend the vehicle and traffic law, in relation to aggravated leaving the scene of an incident without reporting

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new 2 section 600-a to read as follows:

3 S 600-A. AGGRAVATED LEAVING THE SCENE OF AN INCIDENT WITHOUT REPORT-1. A PERSON IS GUILTY OF AGGRAVATED LEAVING THE SCENE OF AN INCI-4 ING. DENT WITHOUT REPORTING WHEN HE OR SHE ENGAGES IN RECKLESS 5 DRIVING AND б THE CRIME OF LEAVING THE SCENE OF AN INCIDENT AS DEFINED IN COMMITS 7 PARAGRAPH A OF SUBDIVISION TWO OF SECTION SIX HUNDRED OF THIS ARTICLE, 8 OTHER THAN FOR THE MERE FAILURE OF SUCH PERSON TO EXHIBIT HIS OR HER LICENSE AND INSURANCE CARD FOR SUCH VEHICLE OR EXCHANGE THE 9 INFORMATION 10 IN SUCH PARAGRAPH, AND CAUSES THE DEATH OF MORE THAN ONE OTHER REOUIRED 11 PERSON AND/OR THE SERIOUS PHYSICAL INJURY OF MORE THAN ONE OTHER PERSON 12 AND EITHER:

13 A. COMMITS SUCH CRIME WHILE KNOWING OR HAVING REASON TO KNOW THAT: (I) HIS OR HER LICENSE OR HIS OR HER PRIVILEGE OF OPERATING A MOTOR VEHICLE 14 IN ANOTHER STATE OR HIS OR HER PRIVILEGE OF OBTAINING A LICENSE TO OPER-15 ATE A MOTOR VEHICLE IN ANOTHER STATE IS SUSPENDED OR REVOKED AND 16 SUCH SUSPENSION OR REVOCATION IS BASED UPON A CONVICTION IN SUCH OTHER STATE 17 18 FOR AN OFFENSE WHICH WOULD, IF COMMITTED IN THIS STATE, CONSTITUTE Α 19 SUBDIVISION TWO OF SECTION SIX HUNDRED OF THIS ARTICLE OR VIOLATION OF

B. HAS PREVIOUSLY BEEN CONVICTED OF VIOLATING SUBDIVISION TWO OF 11 SECTION SIX HUNDRED OF THIS ARTICLE OR ANY OF THE PROVISIONS OF SECTION 12 ELEVEN HUNDRED NINETY-TWO OF THIS CHAPTER WITHIN THE PRECEDING TEN 13 14 YEARS, PROVIDED THAT, FOR THE PURPOSES OF THIS SUBDIVISION, A CONVICTION IN ANY OTHER STATE OR JURISDICTION FOR AN OFFENSE WHICH, IF COMMITTED IN 15 THIS STATE, WOULD CONSTITUTE A VIOLATION OF SUBDIVISION TWO OF SECTION 16 17 SIX HUNDRED OF THIS ARTICLE OR SECTION ELEVEN HUNDRED NINETY-TWO OF THIS CHAPTER SHALL BE TREATED AS A VIOLATION OF SUCH SECTION. 18

A VIOLATION OF THIS SECTION SHALL CONSTITUTE A CLASS C FELONY,
 PUNISHABLE BY A FINE OF NOT LESS THAN TWO THOUSAND FIVE HUNDRED DOLLARS
 NOR MORE THAN FIVE THOUSAND FIVE HUNDRED DOLLARS IN ADDITION TO ANY
 OTHER PENALTIES PROVIDED BY LAW.

23 S 2. This act shall take effect on the first of November next succeed-24 ing the date on which it shall have become a law and shall apply to 25 violations occurring on and after such date.
