AN ACT to amend the penal law, in relation to forcible touching on public transportation

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 130.52 of the penal law, as amended by chapter 264
2 of the laws of 2003, is amended to read as follows:
3 S 130.52 Forcible touching IN THE SECOND DEGREE.
4 A person is guilty of forcible touching IN THE SECOND DEGREE when such
5 person intentionally, and for no legitimate purpose[,]:
6 (1) forcibly touches, SQUEEZES, GRABS OR PINCHES the sexual or other
7 intimate parts of another person for the purpose of degrading or abusing
8 such person; or for the purpose of gratifying the actor's sexual
9 desire[.
10 For the purposes of this section, forcible touching includes squeez-
11 ing, grabbing or pinching.]; OR
12 (2) TOUCHES OR RUBS HIS OR HER SEXUAL OR INTIMATE BODY PARTS AGAINST
13 ANY BODY PART OF ANOTHER PERSON, CLOTHED OR UNCLOTHED, FOR THE PURPOSE
14 OF GRATIFYING SEXUAL DESIRE, OR FOR THE PURPOSE OF DEGRADING OR ABUSING
15 SUCH OTHER PERSON WHILE SUCH OTHER PERSON IS A PASSENGER ON A BUS,
16 TRAIN, OR SUBWAY CAR OPERATED BY ANY TRANSIT AGENCY, AUTHORITY OR COMPA-
17 NY, PUBLIC OR PRIVATE, WHOSE OPERATION IS AUTHORIZED BY NEW YORK STATE
18 OR ANY OF ITS POLITICAL SUBDIVISIONS.
19 Forcible touching IN THE SECOND DEGREE is a class A misdemeanor.
20 S 2. The penal law is amended by adding a new section 130.52-a to read
21 as follows:
22 S 130.52-A FORCIBLE TOUCHING IN THE FIRST DEGREE.
23 A PERSON IS GUILTY OF FORCIBLE TOUCHING IN THE FIRST DEGREE WHEN SUCH
24 PERSON INTENTIONALLY AND FOR NO LEGITIMATE PURPOSE TOUCHES OR RUBS HIS

1 OR HER SEXUAL OR INTIMATE BODY PARTS AGAINST ANY BODY PART OF ANOTHER
2 PERSON, CLOTHED OR UNCLOTHED, FOR THE PURPOSE OF GRATIFYING SEXUAL
3 DESIRE, OR FOR THE PURPOSE OF DEGRADING OR ABUSING SUCH OTHER PERSON AND

8 FORCIBLE TOUCHING IN THE FIRST DEGREE IS A CLASS E FELONY.
9 S 3. This act shall take effect on the first of November next succeed-
10 ing the date on which it shall have become a law.
