AN ACT to amend the parks, recreation and historic preservation law, relation to establishing a resident curator program for the rehabilitation of state park buildings

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. Section 3.09 of the parks, recreation and historic preser-2 vation law is amended by adding a new subdivision 2-h to read as 3 follows:
 - 2-H. BE EMPOWERED, IN ADDITION TO ANY OTHER PROVISION OF LAW AUTHORIZ-ING THE LEASING OF CERTAIN PROPERTY UNDER ITS JURISDICTION, TO ESTABLISH RESIDENT CURATOR PROGRAM TO ENCOURAGE INVESTMENT, RESTORATION AND
 - OCCUPANCY OF BUILDINGS, WHICH SERVE NO PARK RELATED PURPOSE, REMAIN UNOCCUPIED ARE AT RISK OF PROGRESSIVE DETERIORATION, BY AUTHORIZING THE LEASING OF SUCH AT RISK BUILDINGS FOR RESIDENTIAL USE TO
- 10 INDIVIDUALS KNOWN AS RESIDENT CURATORS FOR TERMS OF UP TO FORTY
- THETERM OF SUCH LEASE SHALL RELATE TO THE FINANCIAL 11 LENGTH OF
- INVESTMENT MADE BY THE RESIDENT CURATOR WHICH IS REQUIRED 12 TO REHABILI-AND MAINTAIN THE STRUCTURE FOR RESIDENTIAL OCCUPANCY. 13
