AN ACT to amend chapter 486 of the laws of 1964, establishing and constituting as a separate union free school district certain territory in the town of Canaan in the county of Columbia, and providing for its government, in relation to authorizing such school district to use real property located outside of its territorial limits

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Chapter 486 of the laws of 1964 establishing and constitut-  
2     ing as a separate union free school district certain territory in the  
3     town of Canaan in the county of Columbia, and providing for its govern-  
4     ment, is amended by adding a new section 2-a to read as follows:  
5     S 2-A. NOTWITHSTANDING ANY OTHER LAW, RULE, OR REGULATION TO THE  
6     CONTRARY, IN ADDITION TO THE POWERS GRANTED BY SECTION ONE OF THIS ACT,  
7     SUBJECT TO THE APPROVAL OF THE NEW YORK STATE EDUCATION DEPARTMENT AND  
8     THE BOARD OF COOPERATIVE EDUCATIONAL SERVICES FOR THE SOLE SUPERVISORY  
9     DISTRICT OF RENSSELAER, COLUMBIA, AND GREENE COUNTIES, THE BOARD OF  
10    EDUCATION SHALL BE AUTHORIZED TO UTILIZE PROPERTY LOCATED AT 364 WARREN  
11    STREET, HUDSON, NEW YORK 12534, AND TO ENTER INTO ANY AGREEMENTS NECES-  
12    SARY TO CARRY OUT SUCH AUTHORITY, FOR THE PURPOSE OF PROVIDING INSTRUCC-  
13    TION TO STUDENTS ENROLLED IN THE BERKSHIRE UNION FREE SCHOOL DISTRICT.  
14    S 2. This act shall take effect immediately.
