AN ACT to amend the public authorities law, in relation to the city of New York water board

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Subdivision 2 of section 1045-f of the public authorities 2 law, as added by chapter 513 of the laws of 1984, is amended to read as follows:
 - 2. (A) The water board shall consist of [seven] EIGHT members TO BE appointed [by the mayor.] AS FOLLOWS:
 - (I) FOUR MEMBERS APPOINTED BY THE MAYOR;

- (II) ONE MEMBER APPOINTED BY THE SPEAKER OF THE CITY COUNCIL;
- (III) ONE MEMBER APPOINTED BY THE COMPTROLLER OF THE CITY OF NEW YORK;
- (IV) ONE MEMBER APPOINTED BY THE PUBLIC ADVOCATE; AND
- 10 (V) ONE MEMBER APPOINTED BY THE CITY COUNCIL, WHO SHALL BE A RESIDENT 11 OF THE WATER SHED AREA.
- 12 (B) ALL MEMBERS APPOINTED TO THE BOARD MUST BE CONFIRMED BY THE CITY 13 COUNCIL BEFORE THEY MAY COMMENCE THEIR TERM.
- 14 (C) Terms of office of the members shall be two years except that the terms of four of the board members first appointed shall be one year. At 15 least one member shall have experience in the science of water resource 16 17 development. No member shall be a director of the authority. [The mayor shall appoint a chairman from among the members of the board.] NO 18 19 APPOINTEE SHALL BE AN OFFICER OR EMPLOYEE OF THE CITY, OR HAVE SERVED IN 20 SUCH CAPACITY IN THE PRECEDING SIX MONTH PERIOD. THE CHAIRMAN SHALL BE DULY ELECTED BY THE MEMBERS OF THE BOARD, SUBJECT TO THE SAME QUORUM AND 21 PROVIDED FOR IN SUBDIVISION 22 VOTING REQUIREMENTS AS SEVEN OF 23 SECTION. All members shall continue to hold office until their succes-24 sors are appointed and qualified. Vacancies shall be filled 25 manner provided for original appointments. Vacancies, occurring otherwise than by expiration of term of office, shall be filled in the 26 27 manner as original appointments for the unexpired terms.
 - S 2. This act shall take effect immediately.
