AN ACT to amend the mental hygiene law, in relation to the distribution of educational materials regarding the misuse of and addiction to prescription drugs

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 19.09 of the mental hygiene law is amended by 2 adding a new subdivision (i) to read as follows:

- COMMISSIONER, IN CONSULTATION WITH THE COMMISSIONER OF THE (I) (1)HEALTH, SHALL CREATE OR UTILIZE EXISTING EDUCATIONAL MATERIALS SHALL INCLUDE INFORMATION REGARDING THE DANGERS OF MISUSE AND THE POTEN-TIAL FOR ADDICTION TO PRESCRIPTION DRUGS, TREATMENT RESOURCES AVAILABLE, AND THE PROPER WAY TO DISPOSE OF UNUSED PRESCRIPTION DRUGS. SUCH MATE-RIALS SHALL BE MADE AVAILABLE TO PHARMACISTS AND MAY BE DISTRIBUTED WITH ANY PRESCRIBED DRUG THAT IS A CONTROLLED SUBSTANCE BY A LICENSED BY THE STATE TO DISPENSE PRESCRIPTION DRUGS TO THE PUBLIC PURSUANT TO SECTION SIXTY-EIGHT HUNDRED FIVE OF THE EDUCATION INFORMATION CONTAINED IN SUCH MATERIALS SHALL ALSO BE POSTED ON THE WEBSITE OF THE OFFICE AND THE DEPARTMENT OF HEALTH. SUCH MATERIALS SHALL BE PROVIDED IN LANGUAGES OTHER THAN ENGLISH AS DEEMED APPROPRIATE BY THE COMMISSIONERS.
- 16 (2) UTILIZING DATA THAT IS AVAILABLE TO THE OFFICE, INCLUDING, BUT NOT
  17 LIMITED TO, INFORMATION OBTAINED PURSUANT TO SUBDIVISION FOUR OF SECTION
  18 THIRTY-THREE HUNDRED NINE-A OF THE PUBLIC HEALTH LAW, THE COMMISSIONER
  19 SHALL IDENTIFY THE COUNTIES IN NEW YORK STATE WHERE PRESCRIPTION OPIOID
  20 ABUSE IS MOST PREVALENT. PHARMACISTS LICENSED BY THE STATE TO DISPENSE
  21 PRESCRIPTION DRUGS MAY BE NOTIFIED AT THE DISCRETION OF THE COMMISSIONER
