- AN ACT to amend the public health law, in relation to establishing the Lake Placid part-time off-campus emergency department demonstration program; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The public health law is amended by adding a new section 2 2805-x to read as follows:

3 S 2805-X. LAKE PLACID PART-TIME OFF-CAMPUS EMERGENCY DEPARTMENT DEMON-STRATION PROGRAM. 1. NOTWITHSTANDING ANY INCONSISTENT PROVISION OF LAW, 4 5 OR REGULATION, THE COMMISSIONER SHALL AUTHORIZE ADIRONDACK MEDICAL RULE б CENTER TO OPERATE ITS CURRENT EMERGENCY DEPARTMENT AT ADIRONDACK THE 7 MEDICAL CENTER INTHETOWN OF NORTH ELBA, COUNTY OF ESSEX, AS A 8 PART-TIME OFF-CAMPUS EMERGENCY DEPARTMENT DEMONSTRATION INACCORDANCE 9 WITH THE PROVISIONS OF THIS SECTION.

10 2. SUCH OFF-CAMPUS EMERGENCY DEPARTMENT SHALL OPERATE AT LEAST TWELVE 11 HOURS A DAY, EACH DAY OF THE YEAR.

12 3. SUCH EMERGENCY DEPARTMENT SHALL MEET THE REQUIREMENTS ESTABLISHED 13 ΒY THE FEDERAL CENTERS FOR MEDICARE AND MEDICAID SERVICES FOR A PROVI-DER-BASED OFF-CAMPUS EMERGENCY DEPARTMENT AS WELL AS THOSE 14 REOUIREMENTS COMMISSIONER FOR EMERGENCY SERVICES PROVIDED BY 15 ESTABLISHED ΒY THE GENERAL HOSPITALS; PROVIDED HOWEVER, THE COMMISSIONER SHALL WAIVE 16 THOSE 17 REOUIREMENTS THAT CANNOT REASONABLY BE APPLIED TO AN OFF-CAMPUS 18 PART-TIME EMERGENCY DEPARTMENT.

4. THE COMMISSIONER SHALL, WITHIN EIGHTEEN MONTHS OF THE EFFECTIVE DATE OF THIS SECTION, SUBMIT A REPORT TO THE GOVERNOR AND THE LEGISLA-TURE ON THE SERVICES PROVIDED BY THE PART-TIME OFF-CAMPUS EMERGENCY DEPARTMENT AUTHORIZED BY THIS SECTION, THE EFFECTIVENESS OF SUCH SERVICES IN PROVIDING CARE TO RESIDENTS OF AND VISITORS TO LAKE PLACID AND ITS SURROUNDING COMMUNITIES, AND THE APPLICABILITY OF SUCH A MODEL IN OTHER PARTS OF THE STATE.

8 S 2. This act shall take effect immediately and shall expire and be 9 deemed repealed 5 years after such date.
