AN ACT to define the term "autism" for the purposes of the education law and the mental hygiene law and the term "autism spectrum disorder" for the purposes of the insurance law and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Legislative Intent. The legislature hereby finds that, 1 2 according to Centers for Disease Control and Prevention, as many as one 3 in 50 children may have an autism spectrum disorder (ASD). The leqisla-4 ture further finds that early, continuous and appropriate treatment facilitates the best possible outcome for children diagnosed with ASDs. 5 6 legislature further finds that, while the periodic reformulation of The 7 diagnostic criteria is vital to ensuring the provision of effective care, the State must respond accordingly to guarantee that such changes 8 do not impact the eligibility of individuals currently receiving treat-9 10 under the law. Therefore, the legislature finds it appropriate to ment enact measures preserving the existing rights and entitlements of 11 those 12 diagnosed with pervasive developmental disorders using the fourth edition text revision of the Diagnostic and Statistical Manual of Mental 13 Disorders (DSM-IV TR) as the medical community transitions to 14 criteria 15 implemented by the fifth edition (DSM-5). The legislature finds that in 16 addition to ensuring continued benefits and state services it is impor-17 tant to convene a council to study the transition from (DSM-IV TR) to the criteria implemented by the fifth edition to ensure that individuals 18 who qualify under (DSM-IV TR) will continue to qualify under DSM-5. 19 S 2. Notwithstanding any law to the contrary, 20 "autism," for the

21 purposes of the education law and the mental hygiene law, and "autism 22 spectrum disorder," for the purposes of the insurance law, shall mean 23 either: (1) an autistic disorder, Asperger's disorder, Rett's disorder,

childhood disintegrative disorder, or pervasive developmental disorder not otherwise specified (PDD-NOS), as diagnosed using the fourth edition text revision of the Diagnostic and Statistical Manual of Mental Disorders (DSM-IV TR); or (2) an autism spectrum disorder diagnosed using the most recent edition of the Diagnostic and Statistical Manual of Mental Disorders.

7 S 3. This act shall take effect immediately and shall expire and be 8 deemed repealed two years after such effective date.
