AN ACT to amend the village law and the public officers law, in relation to the residency of certain officers of the village of Victory, county of Saratoga

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 3-300 of the village law is amended by adding two 2 new subdivisions 24 and 25 to read as follows:

- 24. NOTWITHSTANDING THE PROVISIONS OF THIS CHAPTER OR ANY OTHER GENERAL LAW, LOCAL LAW, ORDINANCE, OR SPECIAL ACT, THE VILLAGE BOARD OF TRUSTEES OF THE INCORPORATED VILLAGE OF VICTORY, SARATOGA COUNTY, MAY, BY RESOLUTION, PROVIDE THAT THE VILLAGE CLERK-TREASURER OF THE VILLAGE OF VICTORY, SARATOGA COUNTY, NEED NOT BE A RESIDENT OF SUCH VILLAGE, BUT MUST BE A RESIDENT OF THE COUNTY OF SARATOGA, STATE OF NEW YORK, OR OF A COUNTY WHICH ADJOINS THE COUNTY OF SARATOGA.

IN THE VILLAGE OF VICTORY, COUNTY OF SARATOGA, THE PROVISIONS OF 20 THIS SECTION REQUIRING A PERSON TO BE A RESIDENT OF THE POLITICAL SUBDI-VISION OR MUNICIPAL CORPORATION OF THE STATE FOR WHICH HE OR SHE SHALL 21 BE CHOSEN OR WITHIN WHICH HIS OR HER OFFICIAL FUNCTIONS ARE REQUIRED 22 SHALL NOT PREVENT A PERSON FROM HOLDING THE OFFICE OF 23 EXERCISED, 24 VILLAGE CLERK-TREASURER OF THE VILLAGE OF VICTORY, PROVIDED THAT 25 RESIDES IN THE COUNTY OF SARATOGA OR AN ADJOINING COUNTY WITHIN 26 THE STATE OF NEW YORK. L FUNCTIONS OF VILLAGE CLERK-TREASURER IN ANY OTHER VILLAGE SHALL BE A 2 RESIDENT OF SUCH VILLAGE, UNLESS OTHERWISE PROVIDED BY LAW.

- IN THE VILLAGE OF VICTORY, COUNTY OF SARATOGA, THE PROVISIONS OF THIS SECTION REQUIRING A PERSON TO BE A RESIDENT OF THE POLITICAL SUBDI-5 VISION OR MUNICIPAL CORPORATION OF THE STATE FOR WHICH HE OR SHE SHALL CHOSEN OR WITHIN WHICH HIS OR HER OFFICIAL FUNCTIONS ARE REQUIRED TO 6 7 BE EXERCISED, SHALL NOT PREVENT A PERSON FROM HOLDING THE OFFICE OF 8 DEPUTY CLERK-TREASURER OF THE VILLAGE OF VICTORY, PROVIDED THAT SUCH PERSON RESIDES IN THE COUNTY OF SARATOGA OR AN ADJOINING COUNTY WITHIN 9 10 THE STATE OF NEW YORK.
