AN ACT to amend chapter 751 of the laws of 2005, amending the insurance law and the vehicle and traffic law relating to establishing the accident prevention course internet technology pilot program, in relation to repealing such program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The commissioner of motor vehicles shall not approve any
2 defensive driving program or defensive driving course instructed only
3 over the internet or other such technological means, and shall require
4 that a certified instructor be physically present for the instruction of
5 such programs. All fees received, but not yet expended, by the depart-
6 ment of motor vehicles pursuant to the provisions of article 12-C of the
7 vehicle and traffic law and all other moneys appropriated, credited or
8 transferred thereto from any other fund or source pursuant to law for
9 purposes of administering or implementing the provisions of such article
10 12-C shall be returned to the possession of the state comptroller and
11 the commissioner of taxation and finance within sixty days from the date
12 on which this act shall take effect.

13 S 2. Section 5 of chapter 751 of the laws of 2005, amending the insur-
14 ance law and the vehicle and traffic law relating to establishing the
15 accident prevention course internet technology pilot program, is amended
16 to read as follows:

17 S 5. This act shall take effect on the one hundred eightieth day after
18 it shall have become a law and shall expire and be deemed repealed [five
19 years after the date that the accident prevention course internet, and
20 other technology pilot program is established and implemented by the
21 commissioner of motor vehicles pursuant to article 12-C of the vehicle
22 and traffic law, as added by section three of this act] ON THE EFFECTIVE
23 DATE OF THE CHAPTER OF THE LAWS OF TWO THOUSAND FOURTEEN THAT AMENDED
24 THIS SECTION; provided that any rules and regulations necessary to
25 implement the provisions of this act on its effective date are author-
26 ized and directed to be completed on or before such date; and provided,

1 further, that the commissioner of motor vehicles shall notify the legis-
2 lative bill drafting commission of the date he or she establishes and
3 implements the accident prevention course internet technology pilot
4 program pursuant to article 12-C of the vehicle and traffic law, as
5 added by section three of this act, in order that such commission may
6 maintain an accurate and timely effective data base of the official text
7 of the laws of the state of New York in furtherance of effecting the
8 provisions of section 44 of the legislative law and section 70-b of the
9 public officers law.

10 S 3. The commissioner of motor vehicles shall make any rule, regu-
11 lation and/or repeal necessary for the implementation of this act on or
12 before its effective date.

13 S 4. This act shall take effect on the sixtieth day after it shall
14 have become a law.
