AN ACT to amend the alcoholic beverage control law, in relation to a  
license to sell liquor at retail for consumption on certain premises

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 7 of section 64 of the alcoholic beverage  
2     control law is amended by adding a new paragraph (e-6) to read as  
3     follows:  
4     (E-6) NOTWITHSTANDING THE PROVISIONS OF PARAGRAPH (A) OF THIS SUBDIVI-  
5     SION, THE AUTHORITY MAY ISSUE A RETAIL LICENSE FOR ON-PREMISES CONSUMP-  
6     TION FOR A PREMISES WHICH SHALL BE LOCATED WITHIN TWO HUNDRED FEET OF A  
7     BUILDING OCCUPIED EXCLUSIVELY AS A CHURCH, SYNAGOGUE OR OTHER PLACE OF  
8     WORSHIP, PROVIDED SUCH PREMISES CONSTITUTES A PREMISES FOR THE SALE OF  
9     FOOD OR BEVERAGES AT RETAIL FOR CONSUMPTION ON THE PREMISES LOCATED  
10    WHOLLY WITHIN THE BOUNDARIES OF THE COUNTY OF KINGS, BOUNDED AND  
11    DESCRIBED AS FOLLOWS: ALL THAT TRACT OR PARCEL OF LAND, SITUATE IN THE  
12    CITY OF BEACON, COUNTY OF DUTCHESS, AND THE STATE OF NEW YORK, BOUNDED  
13    AND DESCRIBED AS FOLLOWS:  
14    BEGINNING AT A POINT IN THE SOUTHERLY LINE OF MAIN STREET, SAID POINT  
15    BEING NORTH 53 DEGREES 01 MINUTES 40 SECONDS WEST A DISTANCE OF 250.21  
16    FEET FROM THE INTERSECTION OF THE SAID SOUTHERLY LINE OF MAIN STREET  
17    WITH THE WESTERLY LINE OF TELLER AVENUE, SAID POINT OF BEGINNING ALSO  
18    BEING THE SOUTHEASTERLY CORNER OF THE PORTION OF THE PARCEL DESCRIBED IN  
19    L. 2011 P. 4608 WHICH IS NOW OR FORMERLY OCCUPIED BY THE TOWN CRIER  
20    CAFE.  
21    THENCE THROUGH SAID PARCEL SOUTH 36 DEGREES 58 MINUTES 20 SECONDS WEST A  
22    DISTANCE OF 100.00 FEET TO A POINT, SAID POINT BEING THE SOUTHWESTERLY  
23    CORNER OF THE PORTION OF THE SAID PARCEL WHICH IS NOW OR FORMERLY OCCU-  
24    PIED BY THE TOWN CRIER CAFE;  
25    THENCE ALONG THE NORTHERLY LINE OF LANDS NOW OR FORMERLY CITY OF BEACON  
26    (LIBER 1555 CP. 43) NORTH 53 DEGREES 01 MINUTES 40 SECONDS WEST A  
27    DISTANCE OF 84.98 FEET TO A POINT IN THE EASTERLY LINE OF VETERANS PLACE  
28    (A/K/A NEW STREET);

EXPLANATION--Matter in ITALICS (underscored) is new; matter in brackets  
[ ] is old law to be omitted.

1 THENCE ALONG THE SAID EASTERLY LINE OF VETERANS PLACE (A/K/A NEW STREET)  
2 NORTH 36 DEGREES 58 MINUTES 20 SECONDS EAST A DISTANCE OF 100.00 FEET TO  
3 THE INTERSECTION OF THE SAID EASTERLY LINE OF VETERANS PLACE (A/K/A NEW  
4 STREET) WITH THE SAID SOUTHERLY LINE OF MAIN STREET;  
5 THENCE ALONG THE SAID SOUTHERLY LINE OF MAIN STREET SOUTH 53 DEGREES 01  
6 MINUTES 40 SECONDS EAST A DISTANCE OF 84.98 FEET TO THE POINT OR PLACE  
7 OF BEGINNING.

8 S 2. This act shall take effect immediately.
