AN ACT to amend the education law, in relation to authorizing the state library to coordinate the purchase of electronic databases or other information resources for state agencies, libraries and other governmental entities

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as
2 the "New York state comprehensive information system (NYSCIS) act".
3 S 2. Legislative findings. State agencies and the libraries of New
4 York individually license and purchase electronic databases and other
5 information resources. Access to information is not only vital to the
6 functioning of our democracy, but also to creating an environment conducive to learning, research and innovation. The coordination of the
7 selection and purchase of these resources by the state library would
8 result in greater efficiencies and cost savings for the public and
9 foster improved access to information across the state. Therefore, it is
10 in the best interests of the state and its libraries to enact the "New
11 York state comprehensive information system (NYSCIS) act".
12 S 3. The education law is amended by adding a new section 286 to read
13 as follows:
14 S 286. NEW YORK STATE COMPREHENSIVE INFORMATION SYSTEM. 1. GENERAL.
15 THERE IS HEREBY ESTABLISHED THE NEW YORK STATE COMPREHENSIVE INFORMATION
16 SYSTEM (NYSCIS) TO BE ADMINISTERED BY THE STATE LIBRARY TO ENABLE A
17 COLLABORATIVE AND COST EFFECTIVE APPROACH TO THE PROCUREMENT OF ELECTRONIC DATABASE AND OTHER INFORMATION RESOURCES.
18 2. PARTICIPANTS. ENTITIES PERMITTED TO PARTICIPATE IN NYSCIS ARE STATE
19 AGENCIES, LIBRARY SYSTEMS AND THEIR MEMBER LIBRARIES, AUTHORITIES AND
20 OTHER LOCAL GOVERNMENTAL ENTITIES, INCLUDING, BUT NOT LIMITED TO, THE
21 STATE UNIVERSITY OF NEW YORK AND THE CITY UNIVERSITY OF NEW YORK.
22 3. STATE CONTRACTS. STATE AGENCIES ARE REQUIRED TO COORDINATE THEIR
23 PROCUREMENT FOR INFORMATION RESOURCES THROUGH THE STATE LIBRARY OR ITS

1 4. RESOURCE SELECTION. THE STATE LIBRARY SHALL CREATE AN ADVISORY
2 COMMITTEE REPRESENTATIVE OF PARTICIPANTS IN THIS COLLABORATIVE EFFORT,
3 AND WILL BE TASKED WITH THE SELECTION OF INFORMATION RESOURCES TO BE
4 INCLUDED IN NYSCIS.

5 5. ADMINISTRATION. THE STATE LIBRARY OR ITS DESIGNEE SHALL ADMINISTER
6 NYSCIS AND BE PERMITTED TO RECOUP EXPENSES FOR COORDINATING THESE COLLA-
7 BORATIVE PURCHASING AGREEMENTS.

8 6. RULES AND REGULATIONS. THE COMMISSIONER SHALL ADOPT RULES AND REGU-
9 LATIONS AS ARE NECESSARY TO CARRY OUT THE PURPOSES AND PROVISIONS OF
10 THIS SECTION.

11 S 4. This act shall take effect six months after it shall have become
12 a law. Effective immediately, the addition, amendment and/or repeal of
13 any rule or regulation necessary for the implementation of this act on
14 its effective date is authorized to be made and completed on or before
15 such date.
