AN ACT to amend the environmental conservation law, in relation to the maintenance of unimproved roads

PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Article 54 of the environmental conservation law is amended 2 by adding a new title 14 to read as follows: 3

12 S 54-1401. STATEMENT OF PURPOSE.

IT IS THE INTENT AND PURPOSE OF THIS TITLE:

- 1. TO FUND SAFE, EFFICIENT AND ENVIRONMENTALLY SOUND MAINTENANCE 14 OF 15 SECTIONS OF UNIMPROVED ROADS WHICH HAVE BEEN IDENTIFIED AS SOURCES OF SEDIMENT POLLUTION; AND 16
- 17 2. TO ESTABLISH A DEDICATED AND EARMARKED FUNDING MECHANISM 18 PROVIDES STREAMLINED APPROPRIATION TO THE COUNTY LEVEL AND ENABLES LOCAL 19 OFFICIALS TO ESTABLISH FISCAL AND ENVIRONMENTAL CONTROLS.

- 21 SUBJECT TO ANNUAL APPROPRIATION BY THE LEGISLATURE TO THE DEPARTMENT, 22 FUNDING SHALL BE MADE AVAILABLE BY THE DEPARTMENT FOR THE

- 1 APPORTION THE FUNDS BASED ON WRITTEN CRITERIA IT DEVELOPS TO ESTABLISH 2 PRIORITIES BASED ON PREVENTING AND MITIGATING SEDIMENT POLLUTION.

THE APPORTIONMENT CRITERIA SHALL:

- 5 1. BE BASED ON VERIFIED NEED TO CORRECT POLLUTION PROBLEMS RELATED TO 6 THE ROAD;
- 7 2. CONSIDER THE TOTAL MILES OF UNIMPROVED ROADS MAINTAINED BY LOCAL 8 MUNICIPALITIES OR STATE AGENCIES THAT ARE OPEN TO THE PUBLIC DURING ANY 9 PERIOD OF THE YEAR;
- 10 3. CONSIDER TOTAL MILES OF UNIMPROVED ROADS WITHIN CRITICAL 11 WATERSHEDS; AND
- 12 4. CONSIDER THE COMMITMENTS OF GRANT APPLICANTS TO COMPLY WITH THE 13 NONPOLLUTION REQUIREMENTS ESTABLISHED.

- 1. ADOPT PERFORMANCE STANDARDS;
- 2. PROVIDE FOR A SYSTEM OF AUDIT;
- 18 3. ANNUALLY ASSESS THE PROGRAM AND ANNUALLY REPORT TO THE TRANSPORTA-19 TION COMMITTEE AND ENVIRONMENTAL CONSERVATION COMMITTEES OF BOTH THE 20 ASSEMBLY AND SENATE ON ITS ACCEPTANCE AND EFFECTIVENESS; AND

30 THE SOIL AND WATER CONSERVATION DISTRICT'S ADMINISTRATION OF FUNDING 31 SHALL INCLUDE:

- 1. ADOPTION OF WRITTEN CRITERIA TO ASSURE EQUAL ACCESS FOR ALL ELIGI-33 BLE APPLICANTS WITHIN SPECIFIED FUNDING CATEGORIES;
- 34 2. PROVISION OF DOCUMENTATION THAT APPLICATION HAS BEEN MADE FOR ALL 35 REQUIRED PERMITS;
  - 3. ADOPTION OF PROCEDURES THAT ASSURE A MINIMAL AMOUNT OF PROCEDURAL PAPERWORK;
    - 4. ADOPTION OF WRITTEN CRITERIA TO SPECIFY PRIORITIES;
- 39 5. ADOPTION OF FUNDING CATEGORIES TO PROVIDE FOR SEPARATE BUDGETING 40 FOR:
