AN ACT to amend the public health law, in relation to the artificial nutrition and hydration decision standard

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph (d) of subdivision 5 of section 2981 of the public health law, as added by chapter 752 of the laws of 1990, is amended to read as follows:

18 19 20 (d) A health care proxy may, but need not, be in the following form: Health Care Proxy

6 I (name of principal) hereby appoint (name, 7 home address and telephone number of agent) as my health care agent to 8 make any and all health care decisions for me, except to the extent I 9 state otherwise.

10 This health care proxy shall take effect in the event I become unable 11 to make my own health care decisions.

12 NOTE: Although not necessary, and neither encouraged nor discouraged, you may wish to state instructions or wishes, and limit your agent's 13 authority. [Unless your agent knows your wishes about artificial nutri-14 tion and hydration, your agent will not have authority to decide about 15 16 artificial nutrition and hydration.] Ιf you choose to state instructions, wishes, or limits, please do so below: 17

I direct my agent to make health care decisions in accordance with my wishes and instructions as stated above or as otherwise known to him or her. I also direct my agent to abide by any limitations on his or her authority as stated above or as otherwise known to him or her.

In the event the person I appoint above is unable, unwilling or unavailable to act as my health care agent, I hereby appoint (name, home address and telephone number of alternate agent) as my health care agent.

Subdivision 2 of section 2982 of the public health law, as 21 amended by chapter 230 of the laws of 2004, is amended to read as 22 follows: 23 2. Decision-making standard. After consultation with a licensed physi-24 cian, registered nurse, licensed psychologist, licensed master social 25 worker, or a licensed clinical social worker, the agent shall make 26 health care decisions: (a) in accordance with the principal's wishes, including the principal's religious and moral beliefs; or (b) if the 27 principal's wishes are not reasonably known and cannot with reasonable 28 diligence be ascertained, in accordance with the principal's best inter-29 ests[; provided, however, that if the principal's wishes regarding the 30 administration of artificial nutrition and hydration are not reasonably 31 32 known and cannot with reasonable diligence be ascertained, the agent 33 shall not have the authority to make decisions regarding these meas-34 ures]. 35 3. This act shall take effect on the ninetieth day after it shall S have become a law, provided that the amendments to sections 2981 36 and 37 2982 of the public health law made by sections one and two of this act shall apply to decisions made pursuant to health care proxies created 38 prior to the effective date of this act as well as those created there-39 40 after.
