AN ACT to amend the lien law, in relation to notice of enforcement of a  
lien

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 1 of section 182 of the lien law is amended by  
2     adding four new paragraphs (f), (g), (h) and (i) to read as follows:  
3     (F) "ELECTRONIC MAIL" SHALL MEAN AN ELECTRONIC MESSAGE OR AN EXECUTABLE PROGRAM OR COMPUTER FILE THAT CONTAINS AN IMAGE OF A MESSAGE THAT IS  
4     TRANSMITTED BETWEEN TWO OR MORE COMPUTERS OR ELECTRONIC TERMINALS. SUCH  
5     TERM SHALL INCLUDE ELECTRONIC MESSAGES THAT ARE TRANSMITTED WITHIN OR  
6     BETWEEN COMPUTER NETWORKS.  
7     (G) "LAST KNOWN ADDRESS" SHALL MEAN THE POSTAL ADDRESS OR ELECTRONIC  
8     MAIL ADDRESS PROVIDED BY THE OCCUPANT IN THE LATEST OCCUPANCY AGREEMENT,  
9     OR THE POSTAL ADDRESS OR ELECTRONIC MAIL ADDRESS PROVIDED BY THE OCCUPANT IN A SUBSEQUENT WRITTEN NOTICE OF A CHANGE OF ADDRESS.  
10    (H) "VERIFIED MAIL" SHALL MEAN ANY METHOD OF MAILING THAT IS OFFERED  
11    BY THE UNITED STATES POSTAL SERVICE OR PRIVATE DELIVERY SERVICE THAT  
12    PROVIDES EVIDENCE OF MAILING.  
13    (I) "VERIFIED ELECTRONIC MAIL" MEANS ELECTRONIC MAIL THAT IS TRANSMITTED TO AN E-MAIL ADDRESS THAT THE OCCUPANT HAS VERIFIED AS BEING THEIR  
14    OPERABLE E-MAIL ADDRESS AND HAS EXPRESSLY ELECTED TO RECEIVE NOTICE BY  
15    ELECTRONIC MAIL TO THAT ADDRESS.  
16    S 2. Subdivision 7 of section 182 of the lien law, as added by chapter  
17    975 of the laws of 1983, is amended to read as follows:  
18    7. Enforcement of lien. (A) An owner's lien may be enforced by public  
19    or private sale of the goods that have been removed from the storage  
20    space at a self-service storage facility, in block, or in parcel, at any  
21    time or place and on any terms which are commercially reasonable after  
22    notice to all persons known to claim an interest in the goods. The  
23    notice shall include an itemized statement of the amount due, the  
24    description of the property subject to the lien, the nature of the  
25    proposed sale, a demand for payment within a specified time not less  
26    than 30 days before the sale, and a statement of the amount of the  
27    proposed sale, a demand for payment within a specified time not less

1 than ten days from receipt of notification and a conspicuous statement  
2 that unless the claimant pays within that time the goods will be adver-  
3 tised for sale and sold at public or private sale in a commercially  
4 reasonable manner. The notice shall further include the time and place  
5 of any public or private sale and it shall state that any person claim-  
6 ing an interest in the goods is entitled to bring a proceeding hereunder  
7 within ten days of the service of the notice if he disputes the validity  
8 of the lien, or the amount claimed. The notice shall be personally  
9 delivered to the occupant, or sent by [registered or certified mail,  
10 return receipt requested,] VERIFIED MAIL OR VERIFIED ELECTRONIC MAIL to  
11 the [occupant to the] OCCUPANT'S last KNOWN address provided by the  
12 occupant, pursuant to the occupancy agreement.

13 (B) ANY NOTICE MADE PURSUANT TO THIS SECTION SHALL BE PRESUMED DELIV-  
14 ERED WHEN IT IS DEPOSITED WITH THE UNITED STATES POSTAL SERVICE OR  
15 PRIVATE DELIVERY SERVICE, AND PROPERLY ADDRESSED WITH POSTAGE PREPAID OR  
16 SENT BY VERIFIED ELECTRONIC MAIL TO THE OCCUPANT'S LAST KNOWN ADDRESS.

17 S 3. This act shall take effect immediately.
