AN ACT to amend the general municipal law and the state finance law, in relation to ensuring compliance with the competitive bidding law

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as
2 the "municipal competitive bidding enforcement act."
3 S 2. The general municipal law is amended by adding a new section
4 103-h to read as follows:
5 S 103-H. ENFORCEMENT OF COMPETITIVE BIDDING LAW. 1. DEFINITIONS. (A)
6 "PROCUREMENT ACTION" MEANS ANY TRANSACTION WHICH IS CLAIMED TO CONSTI-
7 TUTE A CONTRACT FOR PUBLIC WORK INVOLVING AN EXPENDITURE OF MORE THAN
8 TWENTY THOUSAND DOLLARS OR A PURCHASE CONTRACT INVOLVING THE EXPENDITURE
9 OF MORE THAN TEN THOUSAND DOLLARS WHICH SHOULD BE AWARDED TO THE LOWEST
10 RESPONSIBLE BIDDER, AS PROVIDED BY SECTION ONE HUNDRED THREE OF THIS
11 ARTICLE.
12 (B) "GOOD FAITH BIDDER" MEANS ANY PERSON WHO HAS SUBMITTED A BID IN
13 RESPONSE TO AN ADVERTISEMENT FOR SEALED BIDS, OR WHO COULD SUBMIT A GOOD
14 FAITH BID ON A PROCUREMENT ACTION.
15 2. COMPTROLLER'S OPINIONS. UPON A COMPLAINT FILED BY A TAXPAYER OF THE
16 POLITICAL SUBDIVISION OR BY A GOOD FAITH BIDDER, THE OFFICE OF THE STATE
17 COMPTROLLER SHALL ISSUE AN OPINION ON WHETHER A PROPOSED PROCUREMENT
18 ACTION BY A POLITICAL SUBDIVISION COMPLIES WITH THE COMPETITIVE BIDDING
19 REQUIREMENTS OF SECTION ONE HUNDRED THREE OF THIS ARTICLE. THE COMPLAINT
20 SHALL SPECIFY THE PROCUREMENT ACTION THAT IS CLAIMED TO VIOLATE SECTION
21 ONE HUNDRED THREE OF THIS ARTICLE. THE TAXPAYER OR GOOD FAITH BIDDER
22 SHALL SERVE A COPY OF THE COMPLAINT ON THE POLITICAL SUBDIVISION PRIOR
23 TO SERVING THE COMPLAINT ON THE COMPTROLLER. UPON THE FILING OF A PRIMA
24 FACIE VALID COMPLAINT WITH THE COMPTROLLER, THE COMPTROLLER SHALL NOTIFY

THE POLITICAL SUBDIVISION. UPON RECEIPT OF SUCH NOTICE FROM THE COMPTROLLER, THE POLITICAL SUBDIVISION MAY NOT PROCEED WITH THE COMPLAINT OF PROCUREMENT ACTION FOR A PERIOD OF THIRTY DAYS. IN RENDERING HIS OR HER OPINION, THE COMPTROLLER MAY CONSULT WITH THE OFFICE OF GENERAL SERVICES AS TO THE REASONABLENESS AND VALIDITY OF ANY BID SPECIFICATIONS. THE COMPTROLLER SHALL ISSUE A WRITTEN OPINION PURSUANT TO THIS SUBDIVISION WITHIN THIRTY DAYS OF SUCH NOTICE TO THE POLITICAL SUBDIVISION AND SHALL PROMPTLY SERVE COPIES OF THE OPINION ON THE POLITICAL SUBDIVISION AND ON THE COMPLAINING PARTY.

3. ATTORNEY GENERAL. IF THE COMPTROLLER'S OPINION IS THAT THE PROCUREMENT ACTION WOULD VIOLATE SECTION ONE HUNDRED THREE OF THIS ARTICLE, THE COMPTROLLER SHALL TRANSMIT A COPY OF THE OPINION TO THE ATTORNEY GENERAL. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE ATTORNEY GENERAL IS AUTHORIZED TO BRING A SPECIAL PROCEEDING IN THE SUPREME COURT TO HAVE A PROCUREMENT ACTION ENJOINED OR DECLARED NULL AND VOID ON THE GROUND THAT IT IS IN VIOLATION OF SECTION ONE HUNDRED THREE OF THIS ARTICLE.

4. DAMAGES TO GOOD FAITH BIDDER. A GOOD FAITH BIDDER MAY BRING AN ACTION IN THE SUPREME COURT TO RECOVER DAMAGES AND ATTORNEY'S FEES FROM A POLITICAL SUBDIVISION, WHICH ENGAGES IN A VIOLATION OF SECTION ONE HUNDRED THREE OF THIS ARTICLE. THE COURT SHALL AWARD DAMAGES AND ATTORNEY'S FEES IF THE COURT FINDS THAT THE GOOD FAITH BIDDER WOULD HAVE BEEN THE LOWEST RESPONSIBLE BIDDER, BUT FOR THE POLITICAL SUBDIVISION'S VIOLATION OF SECTION ONE HUNDRED THREE OF THIS ARTICLE. THE COURT IS AUTHORIZED IN ANY SUCH ACTION TO DECLARE AN ILLEGALLY AWARDED CONTRACT TO BE NULL AND VOID.

(A) IF THE COMPTROLLER HAS ISSUED AN OPINION THAT THE PROCUREMENT ACTION WOULD BE IN VIOLATION OF SECTION ONE HUNDRED THREE OF THIS ARTICLE AND THE POLITICAL SUBDIVISION HAS THEREAFTER PROCEEDED WITH THE PROCUREMENT ACTION, THE MEASURE OF DAMAGES SHALL BE THREE TIMES THE GOOD FAITH BIDDER'S LOST PROFITS.

(B) IF THE COMPTROLLER HAS NOT ISSUED AN OPINION THAT THE PROCUREMENT ACTION WOULD BE IN VIOLATION OF SECTION ONE HUNDRED THREE OF THIS ARTICLE, THE MEASURE OF DAMAGES SHALL BE THE LESSER OF (I) THE GOOD FAITH BIDDER'S LOST PROFITS AND (II) THE DIFFERENCE BETWEEN THE PRICE OF THE NULLIFIED CONTRACT AND ANY AMOUNT THAT THE COURT AWARDS TO THE PERSON WHO PERFORMED ON THE NULLIFIED CONTRACT.

5. CIVIL PENALTY. ANY PERSON WHO SHALL WILFULLY AND INTENTIONALLY VIOLATE THE COMPETITIVE BIDDING REQUIREMENTS OF SECTION ONE HUNDRED THREE OF THIS ARTICLE SHALL BE PERSONALLY LIABLE FOR A CIVIL PENALTY OF NOT MORE THAN ONE THOUSAND DOLLARS. IN A PROCEEDING BROUGHT PURSUANT TO THIS SECTION, THE COMPTROLLER'S OPINIONS AND AUDITS MAY BE ADMITTED INTO EVIDENCE ON THE ISSUE OF THE RESPONDENT'S STATE OF MIND, PROVIDED THAT (A) THE OPINION OR AUDIT WAS ISSUED PRIOR TO THE ALLEGED VIOLATION, (B) THE OPINION OR AUDIT WAS ISSUED NO MORE THAN TEN YEARS PRIOR TO THE ALLEGED VIOLATION, AND (C) THE OPINION OR AUDIT CONCERNED THE SAME KIND OF ITEM OR SAME KIND OF PRACTICE AS THE ALLEGED VIOLATION.

6. COMPLAINT FEE. WHENEVER THE COMPTROLLER ACCEPTS A COMPLAINT FOR FILING PURSUANT TO THIS SECTION, THE COMPTROLLER SHALL REQUIRE AND COLLECT A FEE OF ONE HUNDRED DOLLARS, WHICH SHALL BE PAID INTO THE STATE TREASURY AND WHICH SHALL, SO FAR AS IS NECESSARY, BE APPROPRIATED ANNUALLY BY THE LEGISLATURE TO THE COMPTROLLER TO BE USED IN IMPLEMENTING THIS ARTICLE.

S 3. Section 103 of the general municipal law is amended by adding a new subdivision 14 to read as follows:

14. EXCEPT AS OTHERWISE EXPRESSLY AUTHORIZED BY THIS ARTICLE, A POLITICAL SUBDIVISION MAY NOT REQUIRE THAT BIDS CONFORM TO UNDULY RESTRICTED

1 TIVE SPECIFICATIONS. ALL SPECIFICATIONS SHALL BE DRAFTED SO AS TO
2 PROMOTE OVERALL ECONOMY FOR THE PURPOSES INTENDED AND TO ENCOURAGE
3 COMPETITION IN SATISFYING THE NEEDS OF THE POLITICAL SUBDIVISION. A
4 BRAND NAME MAY BE USED AS A SPECIFICATION ONLY IF THE SPECIFICATION
5 CLEARLY STATES THAT THE BRAND NAME OR EQUIVALENT IS ACCEPTABLE. WHERE A
6 BRAND NAME OR EQUIVALENT SPECIFICATION IS USED IN A BID SOLICITATION,
7 THE SOLICITATION SHALL CONTAIN EXPLANATORY LANGUAGE THAT THE USE OF A
8 BRAND NAME IS FOR THE PURPOSE OF DESCRIBING THE STANDARD OF QUALITY,
9 PERFORMANCE AND CHARACTERISTICS DESIRED AND IS NOT INTENDED TO LIMIT OR
10 RESTRICT COMPETITION. IN ANY OPINION, PROCEEDING OR ACTION BROUGHT
11 PURSUANT TO SECTION ONE HUNDRED THREE-H OF THIS ARTICLE, A BID SPECIFI-
12 CATION DEVELOPED AND PROVIDED BY THE OFFICE OF GENERAL SERVICES SHALL BE
13 DEEMED VALID.

14 S 4. Subdivision 2 of section 103 of the general municipal law, as
15 amended by section 4 of chapter 608 of the laws of 2011, is amended to
16 read as follows:

17 2. Advertisement for bids and offers shall be published in the offi-
18 cial newspaper or newspapers, if any, or otherwise in a newspaper or
19 newspapers designated for such purpose. Such advertisement shall contain
20 a statement of the time when and place where all bids received pursuant
21 to such notice will be publicly opened and read and where the identity
22 of all offerers will be publicly disclosed, and the designation of the
23 receiving device if the political subdivision or district has authorized
24 the receipt of bids and offers in an electronic format. Such board or
25 agency may by resolution designate any officer or employee to open the
26 bids and offers at the time and place specified in the notice. Such
27 designee shall make a record of such bids and offers in such form and
28 detail as the board or agency shall prescribe and present the same at
29 the next regular or special meeting of such board or agency. All bids
30 received shall be publicly opened and read at the time and place so
31 specified and the identity of all offerers shall be publicly disclosed
32 at the time and place so specified. ALL BIDS RECEIVED AND OPENED SHALL
33 BE PUBLIC RECORDS AND SHALL BE AVAILABLE FOR PUBLIC INSPECTION AND COPY-
34 ING. At least five days shall elapse between the first publication of
35 such advertisement and the date so specified for the opening and reading
36 of bids and offers.

37 S 5. Subdivision 2 of section 103 of the general municipal law, as
38 amended by section 5 of chapter 608 of the laws of 2011, is amended to
39 read as follows:

40 2. Advertisement for bids and offers shall be published in the offi-
41 cial newspaper or newspapers, if any, or otherwise in a newspaper or
42 newspapers designated for such purpose. Such advertisement shall contain
43 a statement of the time when and place where all bids received pursuant
44 to such notice will be publicly opened and read and where the identity
45 of all offerers will be publicly disclosed. Such board or agency may by
46 resolution designate any officer or employee to open the bids and offers
47 at the time and place specified in the notice. Such designee shall make
48 a record of such bids and offers in such form and detail as the board or
49 agency shall prescribe and present the same at the next regular or
50 special meeting of such board or agency. All bids received shall be
51 publicly opened and read at the time and place so specified and the
52 identity of all offerers shall be publicly disclosed at the time and
53 place so specified. ALL BIDS RECEIVED AND OPENED SHALL BE PUBLIC
54 RECORDS AND SHALL BE AVAILABLE FOR PUBLIC INSPECTION AND COPYING. At
55 least five days shall elapse between the first publication of such

1 advertisement and the date so specified for the opening and reading of
2 bids and offers.

3 S 6. Subparagraph 1 of paragraph (b) of subdivision 4 of section 35 of
4 the general municipal law, as amended by chapter 692 of the laws of
5 1989, is amended to read as follows:

6 (1) Not later than ninety days after presentation to the governing
7 board of a report of examination performed by the office of the state
8 comptroller, or receipt by the governing board of any report of an
9 external audit performed by an independent public accountant or any
10 management letter in conjunction with such an audit, the governing board
11 may, in its discretion, provide to the comptroller, and file in the
12 office of the clerk, or with the secretary if there is no clerk, of the
13 municipal corporation, industrial development agency, district, agency
14 or activity, a written response to the findings and recommendations, if
15 any, in the report or letter. PROVIDED, HOWEVER, THAT IF SUCH REPORT OR
16 LETTER CONTAINS A FINDING THAT THE COMPETITIVE BIDDING REQUIREMENTS OF
17 SECTION ONE HUNDRED THREE OF THIS CHAPTER WERE VIOLATED, THE GOVERNING
18 BOARD MUST FILE A WRITTEN RESPONSE. In the case of municipal corpo-
19 rations, industrial development agency, districts, agencies or activ-
20 ities subject to examination by the commissioner of education, any writ-
21 ten response shall also be provided to such commissioner.

22 S 7. The state finance law is amended by adding a new section 164-a to
23 read as follows:

24 S 164-A. PROVIDING BID SPECIFICATIONS TO POLITICAL SUBDIVISIONS. THE
25 COMMISSIONER OF GENERAL SERVICES SHALL PROVIDE TO ANY POLITICAL SUBDIVI-
26 SION, AT NO CHARGE, ANY SPECIFICATION THAT THE COMMISSIONER HAS DEVEL-
27 OPED FOR ITEMS TO BE LET FOR BIDS IN PURCHASE CONTRACTS. THE COMMISSION-
28 ER MAY DEVELOP ADDITIONAL SPECIFICATIONS AT THE REQUEST OF ANY POLITICAL
29 SUBDIVISION AND MAY PROVIDE SUCH SPECIFICATIONS TO THE POLITICAL SUBDI-
30 VISION AND MAY CHARGE THE POLITICAL SUBDIVISION FOR THE COST OF DEVELOP-
31 ING SUCH SPECIFICATIONS.

32 S 8. If any clause, sentence, paragraph, section or part of this act
33 shall be adjudged by any court of competent jurisdiction to be invalid,
34 such judgment shall not affect, impair or invalidate the remainder ther-
35 eof, but shall be confined in its operation to the clause, sentence,
36 paragraph, section or part thereof directly involved in the controversy
37 in which such judgment shall have been rendered.

38 S 9. This act shall take effect on the first of January next succeed-
39 ing the date on which it shall have become a law; provided, however, the
40 amendments to subdivision 2 of section 103 of the general municipal law
41 made by section four of this act shall not affect the expiration and
42 reversion of such subdivision pursuant to subdivision (a) of section 41
43 of part X of chapter 62 of the laws of 2003, as amended, when upon such
44 date the provisions of section five of this act shall take effect.
