AN ACT to amend the penal law, in relation to killing or injuring a police animal

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The penal law is amended by adding a new section 195.06-a
2 to read as follows:
3 S 195.06-A KILLING A POLICE WORK DOG OR POLICE WORK HORSE.
4 A PERSON IS GUILTY OF KILLING A POLICE WORK DOG OR POLICE WORK HORSE
5 WHEN SUCH PERSON INTENTIONALLY KILLS A POLICE WORK DOG OR POLICE WORK
6 HORSE WHILE SUCH DOG OR HORSE IS IN THE PERFORMANCE OF ITS DUTIES AND
7 UNDER THE SUPERVISION OF A POLICE OFFICER. FOR PURPOSES OF THIS SECTION,
8 "POLICE WORK DOG" OR "POLICE WORK HORSE," AS THE CASE MAY BE, SHALL MEAN
9 ANY DOG OR HORSE OWNED OR HARBORED BY ANY STATE OR MUNICIPAL POLICE
10 DEPARTMENT OR ANY STATE OR FEDERAL LAW ENFORCEMENT AGENCY, WHICH HAS
11 BEEN TRAINED TO AID LAW ENFORCEMENT OFFICERS AND IS ACTUALLY BEING USED
12 FOR POLICE WORK PURPOSES.
13 KILLING A POLICE WORK DOG OR POLICE WORK HORSE IS A CLASS E FELONY.
14 S 2. This act shall take effect on the first of November next succeeding
15 the date on which it shall have become a law.
