AN ACT to amend the state finance law, in relation to establishing the "rebuild and renew public higher education facilities fund"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The state finance law is amended by adding a new section 99-u to read as follows:

S 99-U. REBUILD AND RENEW PUBLIC HIGHER EDUCATION FACILITIES FUND. 1. 4 THERE IS HEREBY ESTABLISHED IN THE JOINT CUSTODY OF THE STATE COMP-TROLLER AND THE COMMISSIONER OF TAXATION AND FINANCE A SPECIAL FUND TO 5 6 BE KNOWN AS THE "REBUILD AND RENEW PUBLIC HIGHER EDUCATION FACILITIES 7 FUND."

8 THIS FUND SHALL CONTAIN ALL MONEYS APPROPRIATED BY THE LEGISLATURE 2. AND PROCEEDS RECEIVED FROM THE SALE OF STATE PERSONAL INCOME TAX REVENUE 9 10 BONDS BY AUTHORIZED ISSUERS PURSUANT TO SECTIONS SIXTY-EIGHT-A AND SIXTY-EIGHT-B OF THIS CHAPTER. SUCH MONEYS SHALL BE USED ONLY TO PAY FOR 11 12 THE COST OF UNANTICIPATED EMERGENCY REPAIRS INCLUDING MAJOR FACILITY REHABILITATION OR REPLACEMENT TO ANY PUBLIC HIGHER EDUCATION FACILITY 13 CAUSED BY BUT NOT LIMITED TO, FIRE, FLOOD, HAZARDOUS MATERIAL CONTAM-14 15 INATION, INCLEMENT WEATHER, ACTS OF GOD OR ANY OTHER INCIDENT WHICH CAUSES UNANTICIPATED DAMAGE TO SUCH FACILITIES. 16

17 3. EXPENDITURES FROM THIS FUND SHALL BE MADE ONLY UPON THE WARRANT OF A CHANCELLOR OF A PUBLIC HIGHER EDUCATION SYSTEM AND THE ISSUANCE 18 OF A CERTIFICATE OF AVAILABILITY OF FUNDS BY THE DIRECTOR OF THE BUDGET. SUCH 19 WARRANTS AND CERTIFICATES SHALL BE FILED WITH THE CHAIR OF THE SENATE 20 21 FINANCE COMMITTEE, THE CHAIR OF THE ASSEMBLY WAYS AND MEANS COMMITTEE 22 AND THE STATE COMPTROLLER.
