AN ACT to amend the social services law, in relation to allowing local social services districts discretion to provide certain medicaid services and to cover certain categories of eligibility

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 365-a of the social services law is amended by 1 Section 1. adding a new subdivision 10 to read as follows:
 - 10. NOTWITHSTANDING ANY INCONSISTENT PROVISION OF THIS SECTION OR OF PROVISION OF THIS CHAPTER OR OTHER LAW, EACH LOCAL SOCIAL SERVICES DISTRICT IS HEREBY AUTHORIZED TO DETERMINE WHICH, CHOOSES TO PROVIDE TO ELIGIBLE PERSONS OF THOSE SERVICES SERVICES IT OTHERWISE REOUIRED TO BE PROVIDED BY APPLICABLE STATE LAW BUT NOT REQUIRED TO BE PROVIDED BY FEDERAL LAW.
- 9 S 2. Section 366 of the social services law is amended by adding a new 10 subdivision 10 to read as follows:
- NOTWITHSTANDING ANY INCONSISTENT PROVISION OF THIS SECTION OR OF ANY OTHER PROVISION OF THIS CHAPTER OR OTHER LAW, 12 EACH LOCAL SOCIAL 13 SERVICES DISTRICT IS HEREBY AUTHORIZED TO DETERMINE TO WHICH, IF ANY, CATEGORIES OF ELIGIBILITY IT CHOOSES TO PROVIDE MEDICAL ASSISTANCE 14 15 OTHERWISE REQUIRED TO BE PROVIDED BY APPLICABLE STATE LAW BUT NOT REQUIRED TO BE PROVIDED BY FEDERAL LAW.

 ed to developing a services and eligibility plan and distributing the same to local social services districts whereby such districts may make such choices as are authorized by subdivision 10 of section 365-a and subdivision 10 of section 366 of the social services law, as added by sections one and two, respectively, of this act, and applicable federal waivers; and

- 3. shall specify dates by which such services and eligibility plans must be returned to said commissioner for review and approval to implement such plans. A district that does not have an approved plan by the deadline set therefor by the commissioner shall provide all services and categories of eligibility required under the state plan as in effect at that time.
