AN ACT to amend the election law, in relation to designating the state and city universities of New York as participating agencies for voter registration form distribution and assistance, and permitting independent institutions of higher education to do the same upon request

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The opening paragraph of section 5-211 of the election law, as amended by chapter 200 of the laws of 1996, is amended to read as follows:

Each agency designated as a participating agency under the provisions 5 of this section shall implement and administer a program of distribution voter registration forms pursuant to the provisions of this section. 7 The following offices which provide public assistance and/or provide state funded programs primarily engaged in providing services to persons 9 with disabilities are hereby designated as voter registration agencies: designated as the state agencies which provide public assistance are the 10 department of [social services] FAMILY ASSISTANCE and the department of 11 12 Also designated as public assistance agencies are all agencies 13 of local government that provide such assistance. Designated as 14 agencies that provide programs primarily engaged in providing services to people with disabilities are the department of labor, office for the 15 aging, division of veterans' affairs, office of mental health, office of vocational and educational services for individuals with disabilities, 16 17 18 commission on quality of care for the mentally disabled, mental retardation and developmental disabilities, commission for the 19 20 blind and visually handicapped, office of alcoholism and substance abuse services, the office of the advocate for the disabled and all offices 21

Such 16 17 agencies shall also be responsible for providing assistance to applicants in completing voter registration forms, receiving and transmitting 18 19 the completed application form from all applicants who wish to have such 20 form transmitted to the appropriate board of elections. The state board 21 of elections shall, together with representatives of the UNITED 22 department of defense, develop and implement procedures for including 23 recruitment offices of the armed forces of the United States as voter 24 registration offices when such offices are so designated by federal law. 25 state board OF ELECTIONS shall also make request of the United 26 States [Immigration and Naturalization Service] CITIZENSHIP AND 27 GRATION SERVICES to include applications for registration by mail with 28 any materials which are given to new citizens. All institutions of the state university of New York and the city university of New York, shall, 29 the beginning of the school year, and again in January of a year in 30 which the president of the United States is to be elected, provide an 31 32 application for VOTER registration to each student in each such institu-33 The state board of elections may, by regulation, grant a waiver 34 from any or all of the requirements of this section to any office or 35 program of an agency, if it determines that it is not feasible for such office or program to administer such requirement. 36 37

- S 2. Subdivision 4 of section 5-211 of the election law, as added by chapter 659 of the laws of 1994, is amended to read as follows:
- 4. Each participating agency shall provide to each applicant who does not decline to register to vote the same degree of assistance with regard to the completion of the registration application form as is provided by the agency with regard to the completion of its own form unless the applicant refuses such assistance. ALL INSTITUTIONS OF THE STATE UNIVERSITY OF NEW YORK AND ALL DEGREE-GRANTING INSTITUTIONS OF HIGHER EDUCATION DESCRIBED IN ARTICLES ONE HUNDRED FIFTEEN, ONE HUNDRED TWENTY-ONE, ONE HUNDRED TWENTY-THREE, ONE HUNDRED TWENTY-SIX AND ONE HUNDRED TWENTY-NINE OF TITLE VII OF THE EDUCATION LAW WHICH HAVE ELECTED TO BE PARTICIPATING AGENCIES PURSUANT TO THE OPENING PARAGRAPH OF THIS SECTION SHALL ALSO PROVIDE SUCH LEVEL OF ASSISTANCE TO EACH PERSON WHO WISHES TO COMPLETE AN APPLICATION FOR AN ABSENTEE BALLOT.
- S 3. The opening paragraph of subdivision 8 of section 5-211 of the election law, as amended by chapter 659 of the laws of 1994, is amended to read as follows:

Each participating agency, department, division or office that makes available voter registration forms OR ABSENTEE BALLOT APPLICATIONS, OR BOTH, pursuant to this section shall offer with each application for the

services or assistance, PARTICIPATION IN ACTIVITIES OR USE OF FACILITIES of such agency, department, division or office and with each recertification, renewal or change of address form relating to such service or assistance, PARTICIPATION IN ACTIVITIES OR USE OF FACILITIES, a regis-5 tration form together with instructions relating to eligibility to register and for completing the form except that forms used by the 6 7 department of [social services] FAMILY ASSISTANCE for the initial appli-8 cation for services, renewal or recertification for services and change address relating to such services shall physically incorporate a 9 10 voter registration application in a fashion that permits the registration portion of the agency form to be detached therefrom. ALL 11 INSTITUTIONS OF THE STATE UNIVERSITY OF NEW YORK AND ALL DEGREE-GRANTING 12 INSTITUTIONS OF HIGHER EDUCATION DESCRIBED IN ARTICLES 13 ONE HUNDRED 14 FIFTEEN, ONE HUNDRED TWENTY-ONE, ONE HUNDRED TWENTY-THREE, ONE HUNDRED 15 TWENTY-SIX AND ONE HUNDRED TWENTY-NINE OF TITLE VII OF THE EDUCATION LAW 16 WHICH HAVE ELECTED TO BE PARTICIPATING AGENCIES PURSUANT TO THE OPENING 17 PARAGRAPH OF THIS SECTION SHALL ALSO OFFER EACH SUCH APPLICANT AN APPLI-18 CATION FOR AN ABSENTEE BALLOT. Such voter registration application shall designed so as to ensure the confidentiality of the source of the 19 application. S 4. This act shall take effect on the one hundred twentieth day after it shall have become a law, provided however, that effective immediately, the addition, amendment and/or repeal of any rules or regulations necessary for the implementation of this act on its effective date are authorized and directed to be made and completed on or before such
