- AN ACT to amend the town law, the village law and the not-for-profit corporation law, in relation to qualifications to serve as a volunteer firefighter

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 837-o of the executive law, as added by chapter 423 of the laws of 1999, subdivision 2 and paragraph (b) of subdivision 3 as amended by section 41 of part B of chapter 56 of the laws of 2010, is amended to read as follows:

5 S 837-o. Search for arson AND SEX OFFENSE conviction records of volunб teer firefighter applicants. 1. Any person who applies for membership in a fire company, as such term is defined in section three of the volun-7 teer firefighters' benefit law, or who seeks to transfer as a member to 8 9 another fire company, shall be required to authorize the submission of 10 his or her name and other authorized identifying information to the division which shall search its files for records indicating whether the 11 person stands convicted of the crime of arson OR A CRIME WHICH REQUIRES 12 THE PERSON TO REGISTER AS A SEX OFFENDER UNDER ARTICLE SIX-C OF 13 THE 14 CORRECTION LAW. The chief of the fire company to which application is 15 made shall provide written notice to the applicant that a search will be

1 conducted, and if the applicant desires to proceed, he or she shall 2 complete a search request on the form provided for this purpose by the 3 division of criminal justice services.

2. Within ten business days of receipt from the applicant, the chief of the fire company shall send the completed search request form to either (i) the sheriff's department of the county in which the fire company is located, or (ii) the office of fire prevention and control, as follows:

9 (a) the sheriff's department of the county in which the fire company 10 is located shall be responsible for receiving the search requests and 11 processing the search requests with the division within ten business 12 days of receipt from the chief of the fire company, unless the county 13 legislative body adopts and files with the office of fire prevention and 14 control pursuant to the municipal home rule law a local law providing 15 that the sheriff's department shall not have such responsibility;

(b) in all other instances where a county legislative body has adopted a local law pursuant to paragraph (a) of this subdivision, the office of fire prevention and control shall be responsible for receiving search requests and forwarding the search requests to the division.

20 The office of fire prevention and control is hereby authorized to estab-21 lish a communication network with the division for the purpose of 22 forwarding search requests and receiving search results pursuant to 23 paragraph (b) of this subdivision.

searches concerning the application for membership in a 24 (a) All 3. 25 fire company shall be conducted under the provisions of subdivision six 26 of section eight hundred thirty-seven of this article without the assessment of any fee to the applicant or fire company and shall pertain 27 28 solely to ascertaining whether the applicant stands convicted of arson 29 OR A CRIME WHICH REQUIRES THE PERSON TO REGISTER AS A SEX OFFENDER UNDER 30 ARTICLE SIX-C OF THE CORRECTION LAW.

(b) The results of the search shall be communicated in writing, within 31 32 ten business days of receipt from the division, to the chief of the fire 33 company from which the search request originated by either the sheriff's department or the office of fire prevention and control, and shall be 34 35 kept confidential by the chief, except as provided in paragraph (C) of this subdivision. The results of the search shall only state either 36 37 that: (i) the applicant stands convicted of arson AND/OR A CRIME WHICH REQUIRES THE PERSON TO REGISTER AS A SEX OFFENDER UNDER ARTICLE SIX-C OF 38 39 THE CORRECTION LAW, or (ii) the applicant has no record of conviction 40 for arson OR A CRIME WHICH REQUIRES THE PERSON TO REGISTER AS A SEX OFFENDER UNDER ARTICLE SIX-C OF THE CORRECTION LAW. The results of the 41 search shall not divulge any other information relating to the criminal 42 43 history of the applicant.

44 the time an applicant is advised that he or she is ineligible (c) At 45 for membership due to a record of conviction for arson, he or she shall also be advised of the rights to challenge and appeal the information 46 47 contained in the record of conviction as provided in the rules and requ-48 lations of the division. The applicant shall continue to be barred from 49 membership until all administrative and judicial challenges to the accu-50 racy of such information or appeals therefrom, are ultimately resolved 51 in his or her favor, or if such a determination is unchallenged.

6 S 2. Subdivision 17 of section 176-b of the town law, as added by 7 chapter 423 of the laws of 1999, is amended to read as follows:

Upon application by any person for membership in a fire company operating pursuant to this section, the fire chief shall cause the 24 25 applicant's background to be checked pursuant to section eight hundred 26 thirty-seven-o of the executive law for a criminal history involving a conviction for arson AND CONVICTION OF A CRIME WHICH REQUIRES THE PERSON 27 28 TO REGISTER AS A SEX OFFENDER UNDER ARTICLE SIX-C OF THE CORRECTION LAW. 29 WHERE SUCH CRIMINAL HISTORY INFORMATION INCLUDES CONVICTION OF A CRIME WHICH REQUIRES THE PERSON TO REGISTER AS A SEX OFFENDER UNDER ARTICLE 30 SIX-C OF THE CORRECTION LAW, A FIRE COMPANY SHALL DETERMINE WHETHER OR 31 32 NOT SUCH PERSON SHALL BE ELIGIBLE TO BE ELECTED OR APPOINTED AS A VOLUN-33 MEMBER OF SUCH FIRE COMPANY. 36 S 4. Subparagraph 5 of paragraph (c) of section 1402 of the not-for-37 profit corporation law, as added by chapter 423 of the laws of 1999, is 38 amended to read as follows:

39 (5) Upon application by any person for membership in a fire corpo-40 ration operating pursuant to this section, the fire chief shall cause applicant's background to be checked pursuant to section eight 41 the hundred thirty-seven-o of the executive law for a criminal history 42 43 involving a conviction for arson AND CONVICTION OF A CRIME WHICH 44 REQUIRES THE PERSON TO REGISTER AS A SEX OFFENDER UNDER ARTICLE SIX-C OF 45 THE CORRECTION LAW. WHERE SUCH CRIMINAL HISTORY INFORMATION INCLUDES CONVICTION OF A CRIME WHICH REQUIRES THE PERSON TO REGISTER AS A SEX 46 47 OFFENDER UNDER ARTICLE SIX-C OF THE CORRECTION LAW, A FIRE COMPANY SHALL 48 DETERMINE WHETHER OR NOT SUCH PERSON SHALL BE ELIGIBLE TO BE ELECTED OR 49 APPOINTED AS A VOLUNTEER MEMBER OF SUCH FIRE COMPANY. SUCH DETERMINATION 50 MADE IN ACCORDANCE WITH THE CRITERIA ESTABLISHED IN SECTIONS SHALL BE 51 SEVEN HUNDRED FIFTY-TWO AND SEVEN HUNDRED FIFTY-THREE OF THE CORRECTION 52 LAW.
