AN ACT to amend the agriculture and markets law, in relation to fees collected for animal licenses

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 3 of section 109 of the agriculture and markets  
2 law, as amended by chapter 446 of the laws of 2012, is amended to read  
3 as follows:

4     3. Municipalities may provide for the establishment and issuance of  
5 purebred licenses and, in the event they do so, shall provide for the  
6 assessment of a surcharge of at least three dollars PER YEAR PER DOG for  
7 the purposes of carrying out animal population control efforts as  
8 provided in section one hundred seventeen-a of this article. Munici-  
9 palities which issue purebred licenses shall remit such surcharge  
10 collected to the commissioner ON A MONTHLY BASIS.

11     S 2. Subdivision 3 of section 110 of the agriculture and markets law,  
12 as amended by chapter 446 of the laws of 2012, is amended to read as  
13 follows:

14     3. In addition to the fee charged pursuant to subdivision one of this  
15 section, all municipalities issuing dog licenses pursuant to this arti-  
16 cle are required to provide for the assessment of an additional  
17 surcharge of at least one dollar PER YEAR for EACH altered [dogs] DOG  
18 and at least three dollars PER YEAR for EACH unaltered [dogs] DOG for  
19 the purposes of carrying out animal population control efforts as  
20 provided in section one hundred seventeen-a of this article. Such  
21 surcharges shall be submitted by municipalities to the commissioner ON A  
22 MONTHLY BASIS.

23     S 3. Subdivision 4 of section 111 of the agriculture and markets law,  
24 as amended by section 6 of part T of chapter 59 of the laws of 2010, is  
25 amended to read as follows:

1     4. A municipality offering a license for any guide dog, service dog,  
2 hearing dog or detection dog may issue a special tag for identifying  
3 such dog, provided that such tag shall be in addition to the identifica-  
4 tion tag required by subdivision one of this section. The municipality  
5 may prescribe the shape, size, color, and form of imprint of the tag  
6 which shall be a different color and shape than the standard identifica-  
7 tion tag. [Upon application, the commissioner shall furnish such tags  
8 without payment of a fee.]  
9     S 4. This act shall take effect on the sixtieth day after it shall  
10 have become a law.
