AN ACT to amend the public health law, in relation to designating certain additional substances as schedule I hallucinogenic or stimulant controlled substances

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Subdivision (d) of schedule I of section 3306 of the public health law is amended by adding eleven new paragraphs 33, 34, 35, 36, 37, 38, 39, 40, 41, 42 and 43 to read as follows:
