Introduced by Sen. PARKER -- read twice and ordered printed, and when printed to be committed to the Committee on Transportation

AN ACT to amend the vehicle and traffic law, in relation to requiring that the five hour pre-licensing course include a motorcycle safety and awareness component, and that the driver's license examination include two questions concerning motorcycle safety and awareness

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subparagraph (i) of paragraph (a) of subdivision 4 of 2 section 502 of the vehicle and traffic law, as amended by chapter 458 of 3 the laws of 2011, is amended to read as follows:

4 (i) Upon submission of an application for a driver's license, the applicant shall be required to take and pass a test, or submit evidence 5 of passage of a test, with respect to the laws relating to traffic, the 6 7 laws relating to driving while ability is impaired and while intoxicat-8 ed, under the overpowering influence of "Road Rage", or "Work Zone Safe-9 awareness as defined by the commissioner, the law relating to exerty" 10 cising due care to avoid colliding with a parked, stopped or standing authorized emergency vehicle or hazard vehicle pursuant to section elev-11 12 en hundred forty-four-a of this chapter, the ability to read and comprehend traffic signs and symbols and such other matters as the commission-13 may prescribe, and to satisfactorily complete a course prescribed by 14 er 15 the commissioner of not less than four hours and not more than five hours, consisting of classroom driver training, MOTORCYCLE SAFETY AND 16 17 AWARENESS INSTRUCTION and highway safety instruction or the equivalent thereof. Such test shall include at 18 least seven written questions concerning the effects of consumption of alcohol or drugs on the ability 19 of a person to operate a motor vehicle and the legal and financial 20 21 consequences resulting from violations of section eleven hundred nine-22 ty-two of this chapter, prohibiting the operation of a motor vehicle 23 while under the influence of alcohol or drugs. one or more written questions concerning the devastating effects of 1 "Road Rage" on the ability of a person to operate a motor vehicle and 2 3 the legal and financial consequences resulting from assaulting, threat-4 ening or interfering with the lawful conduct of another person legally using the roadway. Such test shall include one or more questions concerning the potential dangers to persons and equipment resulting from 5 б 7 the unsafe operation of a motor vehicle in a work zone. SUCH TEST SHALL 8 INCLUDE AT LEAST TWO WRITTEN QUESTIONS CONCERNING MOTORCYCLE SAFETY AND AWARENESS AND THE POTENTIAL DANGERS TO MOTORCYCLISTS RESULTING FROM 9 THE 10 UNSAFE BEHAVIOR OF A DRIVER OR OPERATION OF A MOTOR VEHICLE SHARING THE ROADWAYS WITH SUCH MOTORCYCLISTS. Such test may include one or more 11 questions concerning the law for exercising due care to avoid colliding 12 with a parked, stopped or standing authorized emergency vehicle or hazard vehicle pursuant to section eleven hundred forty-four-a of this 13 14 15 chapter. Such test shall be administered by the commissioner. The 16 commissioner shall cause the applicant to take a vision test and a test for color blindness. Upon passage of the vision test, the application 17 may be accepted and the application fee shall be payable. 18 19 S 2. This act shall take effect immediately.
