GOLDEN, LANZA, FELDER -- read twice and ordered printed, and when printed to be committed to the Committee on Elections -- reported favorably from said committee, ordered to first report, amended on first report, ordered to a second report and ordered reprinted, retaining its place in the order of second report

AN ACT to amend the election law, in relation to authorizing the use of mechanical voting machines for non-federal elections in the city of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 7-200 of the election law, as
2 amended by chapter 181 of the laws of 2005, is amended to read as
3 follows:
4 1. The board of elections of the city of New York and other county
5 boards of elections may adopt any kind of voting machine or system
6 approved by the state board of elections, or the use of which has been
7 specifically authorized by law; and thereupon such voting machine or
8 system may be used at any or all elections and shall be used at all
9 general or special elections held by such boards in such city, town or
10 village and in every contested primary election in the city of New York
11 and in every contested primary election outside the city of New York in
12 which there are one thousand or more enrolled voters qualified to vote.
13 No more than two types of voting machines or systems may be used by any
14 local board of elections at a single election. Notwithstanding the other
15 provisions of this subdivision, any local board of elections may borrow
16 or lease for use on an experimental basis for a period of not more than
17 one year each, voting machines or systems of any type approved by the
18 state board of elections. NOTWITHSTANDING ANY OTHER PROVISIONS OF LAW,
19 INCLUDING BUT NOT LIMITED TO ANY PROVISIONS OF THIS CHAPTER THAT WOULD
20 RENDER IMPLEMENTATION OF THE AUTHORITY CONFERRED BY THIS SENTENCE INFEA-
21 SIBLE OR IMPRACTICABLE, THE BOARD OF ELECTIONS OF THE CITY OF NEW YORK

1 IS HEREBY AUTHORIZED TO PREPARE, DEPLOY AND UTILIZE MECHANICAL LEVER
2 VOTING MACHINES IN AND FOR ANY NON-FEDERAL ELECTIONS CONDUCTED PURSUANT
3 TO SECTION 8-100 OF THIS CHAPTER. SHOULD THE BOARD OF ELECTIONS OF THE
4 CITY OF NEW YORK UTILIZE SUCH MECHANICAL LEVER VOTING MACHINES IN ANY
5 SUCH ELECTION, THE BOARD MUST ALSO PROVIDE A VOTING SYSTEM THAT MEETS
6 THE REQUIREMENTS OF PARAGRAPHS A, B AND C OF SUBDIVISION TWO OF SECTION
7 7-202 OF THIS TITLE IN EACH POLLING SITE.

8 S 2. This act shall take effect immediately.
