AN ACT to amend the state finance law, the public health law and the education law, in relation to requiring gluten cross contamination safeguards in food establishments owned, operated or leased by any department or agency of the state or the state university of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The state finance law is amended by adding a new section 2 146-a to read as follows:

3 146-A. CONTRACTS FOR FOOD SERVICE ESTABLISHMENTS. NOTWITHSTANDING S 4 ANY OTHER PROVISIONS OF LAW, ALL NEW CONTRACTS, RENEWAL CONTRACTS OR 5 ORDERS FOR AN EXISTING CONTRACT MADE AND AWARDED BY ANY DEPART-CHANGE 6 MENT OR AGENCY OF THE STATE OR THE STATE UNIVERSITY OF NEW YORK, FOR THE 7 OPERATION OF A FOOD SERVICE ESTABLISHMENT, SHALL CONTAIN A PROVISION 8 THE CONTRACTOR OR VENDOR OPERATING SUCH ESTABLISHMENT IN A REOUIRING STATE-OWNED, OPERATED OR LEASED BUILDING TO TAKE REASONABLE PRECAUTIONS 9 10 AVERT THE CROSS-CONTAMINATION OF GLUTEN-FREE FOODS PREPARED BY SUCH ТΟ ESTABLISHMENT BY FOOD CONTAINING GLUTEN. 11

12 S 2. Section 206 of the public health law is amended by adding a new 13 subdivision 29 to read as follows:

29. THE COMMISSIONER, IN CONSULTATION WITH THE COMMISSIONER OF EDUCA-14 15 TION, SHALL PROMULGATE RULES AND REGULATIONS SPECIFYING REASONABLE METH-ODS TO AVERT THE CROSS-CONTAMINATION OF GLUTEN-FREE 16 FOODS ΒY FOODS 17 CONTAINING GLUTEN DURING THE PREPARATION OF SUCH FOOD IN CAFETERIAS AND RESTAURANTS OR ANY OTHER FOOD ESTABLISHMENT OPERATED BY A 18 VENDOR OR CONTRACTOR ON PROPERTIES OWNED, OPERATED OR LEASED BY ANY DEPARTMENT OR 19 AGENCY OF THE STATE OR THE STATE UNIVERSITY OF NEW YORK. 20

21 S 3. The education law is amended by adding a new section 101-c to 22 read as follows:

RULES AND REGULATIONS; GLUTEN CROSS-CONTAMINATION PREVENTION. 2 THE COMMISSIONER, IN CONSULTATION WITH THE COMMISSIONER OF HEALTH, SHALL 3 PROMULGATE RULES AND REGULATIONS SPECIFYING REASONABLE METHODS TO AVERT 4 THE CROSS-CONTAMINATION OF GLUTEN-FREE FOODS BY FOODS CONTAINING GLUTEN 5 DURING THE PREPARATION OF SUCH FOOD IN CAFETERIAS AND RESTAURANTS OR ANY 6 OTHER FOOD ESTABLISHMENT OPERATED BY A VENDOR OR CONTRACTOR ON PROPER-7 TIES OWNED, OPERATED OR LEASED BY THE STATE UNIVERSITY OF NEW YORK.

8 S 4. This act shall take effect on the thirtieth day after it shall 9 have become a law, provided, however, that effective immediately, the 10 addition, amendment, or repeal of any rule or regulation necessary for 11 the implementation of this act on its effective date is authorized and 12 directed to be made and completed on or before such effective date.
