AN ACT to amend the social services law, in relation to juvenile justice records

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 372 of the social services law is amended by adding a new subdivision 4-c to read as follows:

3 4-C. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE NEW YORK CITY 4 ADMINISTRATION FOR CHILDREN'S SERVICES MAY RELEASE RECORDS OF ARRESTS 5 CONVICTIONS, HISTORIES OF ADMISSION TO SECURE AND NON-SECURE AND 6 DETENTION FACILITIES, AND RECORDS OF BEHAVIOR IN SUCH FACILITIES, TO THE 7 NEW YORK CITY DEPARTMENT OF CORRECTION UPON ITS REQUEST, FOR ANY INDI-8 FORMERLY IN THE CUSTODY OF THE NEW YORK CITY ADMINIS-VIDUAL WHO WAS 9 TRATION FOR CHILDREN'S SERVICES OR A PREDECESSOR AGENCY AND WHO HAS BEEN ADMITTED INTO THE CUSTODY OF THE NEW YORK CITY DEPARTMENT OF CORRECTION. 10 NOTWITHSTANDING THE PROVISIONS OF THIS SUBDIVISION, THE NEW YORK 11 CITY ADMINISTRATION FOR CHILDREN'S SERVICES SHALL NOT RELEASE TO THE NEW YORK 12 CITY DEPARTMENT OF CORRECTION ANY SUCH RECORD THAT IS DATED EARLIER THAN 13 14 TENYEARS PRIOR ТΟ THE DATE OF SUCH REQUEST, EXCEPT THAT A RECORD OF ESCAPE OR ATTEMPTED ESCAPE MAY BE RELEASED REGARDLESS 15 THE DATE OF OF SUCH RECORD. RECORDS RELEASED PURSUANT TO THIS SUBDIVISION SHALL NOT BE 16 17 REDISCLOSED EXCEPT AS OTHERWISE PERMITTED BY LAW AND UPON THE APPROVAL OF THE DEPARTMENT. 18
