AN ACT to amend the vehicle and traffic law, in relation to all terrain vehicles and agricultural use

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 401 of the vehicle and traffic law is amended by adding a new subdivision 14 to read as follows:

3 14. REGISTRATION OF ALL TERRAIN VEHICLES OPERATED UPON PUBLIC HIGHWAYS CONNECTING PORTIONS OF A FARM OR FARMS, MUNICIPAL SANITARY LANDFILLS AND 5 LICENSED MOTOR VEHICLE REPAIR SHOPS. NOTWITHSTANDING ANY OTHER PROVISION THECONTRARY, \mathtt{ALL} TERRAIN VEHICLES TO BE OPERATED BY ANY PERSON, UPON A PUBLIC HIGHWAY FOR THE PURPOSE OF TRAVELING BY 7 THE MOST 8 IN NO EVENT FURTHER THAN TWENTY-FIVE MILES ONE-WAY DIRECT ROUTE, BUT 9 FROM A POINT ON A FARM AS DESIGNATED BY THE VEHICLE OWNER AND SET IN AN ATTACHMENT TO THE VEHICLE REGISTRATION, (A) BETWEEN FIELDS, BUILD-10 INGS, AND FACILITIES MANAGED OR OPERATED AS PART OF A SINGLE FARM ENTER-11 PRISE IN CONNECTION WITH PRODUCTION, HARVESTING, PROCESSING OR MARKETING 12 ON THAT FARM OF CROPS, LIVESTOCK, OR LIVESTOCK PRODUCTS PRODUCED ON THAT 13 14 FARM; OR (B) FOR THE PURPOSE OF TRANSPORTING MATERIALS FROM A FARM TO THE NEAREST AVAILABLE MUNICIPAL 15 SANITARY LANDFILL; OR (C) 16 PURPOSE OF TRANSPORTING THE ALL TERRAIN VEHICLE TO A MOTOR VEHICLE 17 REPAIR SHOP LICENSED PURSUANT TO THIS CHAPTER FOR THE REPAIR OR MENT OF EQUIPMENT PROVIDED THAT, IN ADDITION TO THE ROUTE RESTRICTIONS 18 19 SET FORTH IN THIS SUBDIVISION, NO SUCH TRANSPORT SHALL BE AUTHORIZED (I) 20 IF SUCH VEHICLE HAS AN OUT-OF-SERVICE DEFECT RELATING TO LOAD STEERING COMPONENTS AND/OR COUPLING DEVICES, OR 21 MENT, BRAKE SYSTEMS, 22 AFTER IT HAS BEEN PLACED OUT-OF-SERVICE; (II) ON ANY LIMITED 23 (III) DURING THE PERIOD OF ONE HOUR BEFORE SUNSET TO ONE HIGHWAY; AND 24 HOUR AFTER SUNRISE, MAY BE REGISTERED AS PROVIDED IN THIS SUBDIVISION.

WITH THE COMMISSIONER OR WITH ANY AGENT OF THE COMMISSIONER, AN APPLICA-TION FOR REGISTRATION OF SUCH VEHICLE, ADDRESSED TO THE COMMISSIONER, 3 AND ON A BLANK FORM TO BE FURNISHED BY THE COMMISSIONER FOR PURPOSE, CONTAINING THE INFORMATION REQUIRED BY SUBDIVISION ONE OF THIS 5 SECTION AND SUCH OTHER INFORMATION AS THE COMMISSIONER SHALL REQUIRE. 6 THE COMMISSIONER OR AGENT SHALL MAKE SUCH INVESTIGATION, AS HE OR SHE SHALL DETERMINE NECESSARY, AND IF SATISFIED THAT THE VEHICLE IS TO BE 7 OPERATED EXCLUSIVELY AS PROVIDED IN THIS SUBDIVISION SHALL, UPON THE 8 PAYMENT OF A FEE OF ONE DOLLAR, ASSIGN TO SUCH VEHICLE A DISTINCTIVE 9 10 NUMBER AND ISSUE AND DELIVER TO THE APPLICANT A SET OF NUMBER PLATES AND CERTIFICATE OF REGISTRATION IN SUCH FORM AS THE COMMISSIONER SHALL 11 PRESCRIBE, INDICATING THE EXTENT TO WHICH THE VEHICLE REGISTERED MAY BE 12 OPERATED ON THE PUBLIC HIGHWAYS AND SUCH VEHICLE MAY BE OPERATED ONLY AS 13 14 SO INDICATED. FOR THE PURPOSES OF THIS SUBDIVISION, THE TERMS "FARM" AND 15 "CROPS, LIVESTOCK OR LIVESTOCK PRODUCTS," SHALL HAVE THE SAME MEANING AS "LAND USED IN AGRICULTURAL PRODUCTION" AND "CROPS, LIVESTOCK AND LIVE-16 STOCK PRODUCTS, " RESPECTIVELY, AS DEFINED IN SECTION THREE HUNDRED ONE 17 THE AGRICULTURE AND MARKETS LAW, EXCEPT THAT FARMERS WITH AN AVERAGE 18 19 GROSS SALES VALUE OF AT LEAST ONE THOUSAND DOLLARS PER YEAR OF CROPS, LIVESTOCK, AND LIVESTOCK PRODUCTS SHALL BE ELIGIBLE TO REGISTER VEHICLES 20 21 PURSUANT TO THIS SUBDIVISION.

22 S 2. This act shall take effect on the ninetieth day after it shall 23 have become a law.
