AN ACT to amend the social services law, in relation to establishing the YES annex youth organization pilot program in Brooklyn, Syracuse and Buffalo

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Short title. This act shall be known and may be cited as  
2     the "YES annex youth organization pilot program".

3     S 2. The social services law is amended by adding a new section 410-n  
4     to read as follow:

5     S 410-N. YES ANNEX YOUTH ORGANIZATION PILOT PROGRAM. 1. THE COMMIS-  
6     SIONER SHALL ESTABLISH A PILOT PROGRAM FOR THE PURPOSE OF DISBURSING  
7     GRANTS TO YOUTH ORGANIZATIONS SEEKING TO UTILIZE LATERAL SYNERGIES AND  
8     WORK COOPERATIVELY TO MEET THE NEEDS OF TODAY'S YOUTH. UNDER THIS PILOT  
9     PROGRAM MULTIPLE YOUTH SERVICE ORGANIZATIONS WILL BE EMPOWERED TO JOIN  
10    TOGETHER UNDER ONE UMBRELLA AND CREATE A ONE-STOP-SHOP TO PROVIDE  
11    SERVICES AND ACTIVITIES TO CHILDREN INCLUDING, BUT NOT LIMITED TO TUTOR-  
12    ING AND MENTORING PROGRAMS, COUNSELING, SPORTS AND RECREATIONAL ACTIV-  
13    ITIES, CAREER COUNSELING, S.A.T. PREPARATION, LIFE SKILLS CLASSES AND  
14    HEALTH AND FITNESS INSTRUCTION.

15    2. THE COMMISSIONER SHALL ESTABLISH CRITERIA AND SET A SCHEDULE FOR  
16    ACCEPTING PROPOSALS FOR GRANT AWARDS FROM INTERESTED YOUTH ORGANIZATION  
17    GROUPS WITHIN ELIGIBLE COMMUNITIES.

18    3. THE COMMISSIONER UPON REVIEW OF PROPOSALS SHALL AWARD AND DISBURSE  
19    THREE GRANTS, IN THE SUM OF ONE HUNDRED THOUSAND DOLLARS TO ONE GROUP  
20    SELECTED FROM EACH OF THE FOLLOWING HIGH RISK ELIGIBLE COMMUNITIES: ONE  
21    FROM THE BOROUGH OF BROOKLYN IN THE CITY OF NEW YORK, ONE IN THE CITY OF  
22    SYRACUSE AND ONE IN THE CITY OF BUFFALO.

23    4. SELECTED GRANT RECIPIENTS SHALL SUBMIT A REPORT, IN ACCORDANCE WITH  
24    CRITERIA ESTABLISHED BY THE COMMISSIONER, TO THE COMMISSIONER AND THE

1 LEGISLATURE ON THE EFFECTIVENESS OF THE PILOT PROGRAM AND THE RESULTS  
2 ACHIEVED TWO YEARS AFTER SUCH GRANTS ARE DISBURSED.

3 S 3. This act shall take effect immediately; provided, however, the  
4 state commissioner of social services shall have the power to promulgate  
5 any rules or regulations necessary for the implementation of this act on  
6 its effective date.
