AN ACT to amend the agriculture and markets law, in relation to limiting disclosure of certain information

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     Section 1. The agriculture and markets law is amended by adding a new  
2     section 23-a to read as follows:  
3     S 23-A. LIMITATION ON DISCLOSURES ASSOCIATED WITH FREEDOM OF INFORMA-  
4     TION LAW. 1. NOTWITHSTANDING ARTICLE SIX OF THE PUBLIC OFFICERS LAW, THE  
5     COMMISSIONER, ANY OFFICER OR EMPLOYEE OF THE DEPARTMENT, OR ANY CONTRAC-  
6     TOR OR COOPERATOR OF THE DEPARTMENT, SHALL NOT DISCLOSE PURSUANT TO A  
7     REQUEST MADE PURSUANT TO SUCH ARTICLE:  
8     (A) INFORMATION VOLUNTARILY PROVIDED BY AN OWNER OR OPERATOR OF A FARM  
9     OPERATION IN ORDER TO PARTICIPATE IN THE NEW YORK STATE CATTLE HEALTH  
10    ASSURANCE PROGRAM OR ANY SUCCESSOR CATTLE HEALTH PROGRAM ESTABLISHED BY  
11    THE DEPARTMENT PURSUANT TO SUBDIVISION FORTY-ONE OF SECTION SIXTEEN OF  
12    THIS ARTICLE (COLLECTIVELY, "NYSCHAP"); OR  
13    (B) INFORMATION OTHERWISE CREATED AND MAINTAINED BY THE COMMISSIONER  
14    ABOUT FARM OPERATIONS FOR WHICH INFORMATION DESCRIBED IN PARAGRAPH (A)  
15    OF THIS SUBDIVISION IS VOLUNTARILY PROVIDED.  
16    2. THE DISCLOSURE OF INFORMATION UNDER SUBDIVISION ONE OF THIS SECTION  
17    SHALL NOT CONSTITUTE A WAIVER OF ANY APPLICABLE PRIVILEGE OR PROTECTION  
18    UNDER FEDERAL OR STATE LAW, INCLUDING TRADE SECRET PROTECTION.  
19    3. THE MEANING OF THE TERM "FARM OPERATION" AS USED IN THIS SECTION  
20    SHALL BE THE SAME AS IT IS DEFINED IN SUBDIVISION ELEVEN OF SECTION  
21    THREE HUNDRED ONE OF THIS CHAPTER.  
22    S 2. This act shall take effect immediately.
