- AN ACT to amend the real property tax law, in relation to certain veterans' exemptions

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph (a) of subdivision 1, and subdivisions 3 and 3-a of section 458-a of the real property tax law, paragraph (a) of subdivision 1 as amended by chapter 179 of the laws of 2006, subdivision 3 as amended by chapter 646 of the laws of 2004 and as further amended by paragraph (b) of section 1 of part W of chapter 56 of the laws of 2010, subdivision 3-a as added by chapter 531 of the laws of 2006, are amended to read as follows:

8 (a) "Period of war" means the Spanish-American war; the Mexican border 9 period; World War I; World War II; the hostilities, known as the Korean war, which commenced June twenty-seventh, nineteen hundred fifty and 10 terminated on January thirty-first, nineteen hundred fifty-five; the 11 hostilities, known as the Vietnam war, which commenced February twenty-12 eighth, nineteen hundred sixty-one and terminated on May seventh, nine-13 14 teen hundred seventy-five; [and] the hostilities, known as the Persian 15 conflict, Gulf which commenced August second, nineteen hundred 16 ninety[.]; THE HOSTILITIES PARTICIPATED IN BY THE MILITARY FORCES OF THE 17 UNITED STATES IN THE GLOBAL WAR ON TERRORISM FROM SEPTEMBER ELEVENTH, 18 TWO THOUSAND ONE THROUGH THE END OF SUCH HOSTILITIES; AND THE HOSTIL-ITIES PARTICIPATED IN BY THE MILITARY FORCES OF 19 THE UNITED STATES INTHEATERS IN SOMALIA FROM AUGUST, NINETEEN HUNDRED 20 NATO RELATED COMBAT NINETY-TWO THROUGH MARCH, NINETEEN HUNDRED NINETY-FOUR, BOSNIA IN DECEM-21 22 BER, NINETEEN HUNDRED NINETY-FIVE THROUGH NOVEMBER, TWO THOUSAND FOUR 23 AND KOSOVO IN APRIL, NINETEEN HUNDRED NINETY-NINE THROUGH JUNE, NINETEEN 24 HUNDRED NINETY-NINE.

3. Application for exemption must be made by the owner, or all of the owners, of the property on a form prescribed by the commissioner. The

owner or owners shall file the completed form in the assessor's office 1 2 on or before the appropriate taxable status date; PROVIDED, HOWEVER . 3 THAT SUCH EXEMPTION SHALL BE EFFECTIVE RETROACTIVELY TO THE PRIOR FISCAL 4 YEAR, BUT NOT BEYOND ONE YEAR; AND, PROVIDED, FURTHER, THAT IF SUCH 5 EXEMPTION IS GRANTED IT SHALL BE PRORATED TO THE DATE UPON WHICH THE The exemption shall continue in full 6 VETERAN FILED THE APPLICATION. 7 force and effect for all appropriate subsequent tax years and the owner owners of the property shall not be required to refile each year. 8 or Applicants shall be required to refile on or before the appropriate 9 10 taxable status date if the percentage of disability percentage increases decreases or may refile if other changes have occurred which affect 11 or 12 qualification for an increased or decreased amount of exemption. Notwithstanding the provisions of this section or any other 17 provision of law, in a city having a population of one million or more, applications for the exemption authorized pursuant to this section shall 18 19 be considered timely filed if they are filed on or before the fifteenth 20 day of March of the appropriate year; PROVIDED, HOWEVER, THAT SUCH 21 EXEMPTION SHALL BE EFFECTIVE RETROACTIVELY TO THE PRIOR FISCAL YEAR, BUT 22 NOT BEYOND ONE YEAR; AND, PROVIDED, FURTHER, THAT IF SUCH EXEMPTION IS GRANTED IT SHALL BE PRORATED TO THE DATE UPON WHICH THE VETERAN FILED 23 24 THE APPLICATION.
