AN ACT to amend the public health law, in relation to directing clinical laboratories to provide results of tests directly to the person on whom the test was performed

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The public health law is amended by adding a new section 2 576-d to read as follows:
 - S 576-D. RELEASE OF TEST RESULTS TO PATIENTS. 1. A CLINICAL LABORATORY SHALL, UPON REQUEST, REPORT THE RESULTS OF ANY TEST, EXAMINATION OR ANALYSIS OF A SPECIMEN SUBMITTED FOR EVIDENCE OF HUMAN DISEASE OR MEDICAL CONDITION DIRECTLY TO THE PERSON ON WHOM THE TEST WAS PERFORMED, SUBSEQUENT TO WHEN THE TEST HAS BEEN REPORTED TO THE PHYSICIAN OR HEALTH CARE PRACTITIONER WHO ORDERED SUCH TEST OR EXAMINATION, EXCEPT IN CASES OF IMMEDIATE MEDICAL JEOPARDY WHEN RESULTS MAY BE PROVIDED IMMEDIATELY TO THE PATIENT.
- 2. NOTHING IN THIS SECTION SHALL AUTHORIZE A CLINICAL LABORATORY TO ENGAGE IN THE PRACTICE OF ANY HEALTH CARE PROFESSION UNDER TITLE EIGHT OF THE EDUCATION LAW. THE REPORT ISSUED PURSUANT TO THIS SECTION SHALL
- 14 CONTAIN A CLEAR STATEMENT, PRESENTED IN A PROMINENT MANNER, TO THE 15 EFFECT THAT THE REPORT SHOULD NOT BE VIEWED AS MEDICAL ADVICE AND IS NOT
- 16 MEANT TO REPLACE DIRECT COMMUNICATION WITH A PHYSICIAN OR OTHER HEALTH
- 17 CARE PRACTITIONER.
