Introduced by Sen. GOLDEN -- read twice and ordered printed, and when printed to be committed to the Committee on Civil Service and Pensions

AN ACT to amend the civil service law, in relation to scheduling an examination for any position or positions in the classified services that provides child protection services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Subdivision 4 of section 7 of the civil service law, as Section 1. added by chapter 790 of the laws of 1958, is amended to read as follows: 4. Subject to the provisions of this chapter and the rules established thereunder, he shall make regulations for and have control of examina-5 tions for the service of the state, and the civil divisions thereof, except civil divisions for which a municipal commission performs function, and shall supervise and preserve the records NOTWITHSTANDING ANY PROVISION OF LAW TO THE CONTRARY, UPON THE 8 WRITTEN 9 REQUEST OF A MUNICIPAL CIVIL SERVICE COMMISSION OR PERSONNEL OFFICER AS 10 APPLICABLE, WHERE SUCH LOCAL COMMISSION OR PERSONNEL OFFICER THE NEED FOR THE IMMEDIATE SCHEDULING OF AN EXAMINATION FOR ANY POSITION 11 POSITIONS IN THE CLASSIFIED SERVICES THAT PROVIDES CHILD PROTECTION 12 13 SERVICES PURSUANT TO TITLE SIX OF ARTICLE SIX OF THESOCIAL SHALL IMMEDIATELY ANNOUNCE, SCHEDULE, SCORE, AND PRESIDENT 14 15 CERTIFY THE RESULTS OF SUCH EXAMINATION. SUCH EXAMINATION SHALL HAVE OTHER EXAMINATIONS THAT HAVE BEEN REQUESTED OR ARE 16 PRIORITY OVER ALL OTHERWISE BEING SCHEDULED. IN NO EVENT SHALL THE PROCESS OF 17 18 EXAMINATION TAKE LONGER THAN SIXTY DAYS. THIS PROVISION SHALL BE 19 APPLICABLE NOTWITHSTANDING THE EXISTENCE OF AN EXISTING CIVIL 20 LIST AND NOTWITHSTANDING THE ABSENCE OF CURRENTLY VACANT POSITIONS IN 21 SUCH CLASSIFIED TITLE OR TITLES.

S 2. This act shall take effect immediately.
