AN ACT to amend the estates, powers and trusts law, in relation to powers of attorney in relation to decedents' estates required to be in writing and recorded

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. Section 13-2.3 of the estates, powers and trusts law is 1 amended by adding a new paragraph (e) to read as follows:
 - NOTWITHSTANDING THE PROVISIONS OF ANY OTHER STATUTE OR RULE, NO INSTRUMENT CONTAINING A DELEGATION OF POWERS, ASSIGNMENT OF ARRANGEMENT, OR ANY INSTRUMENT OF LIKE IMPORT CREATED FOR THE PURPOSE OF PARTICIPATING ON BEHALF OF AN INDIVIDUAL IN ANY APPLICATION SEEKING THE RECOVERY OF PROPERTY PURSUANT TO SECTION FOURTEEN HUNDRED SIXTEEN OF THE ABANDONED PROPERTY LAW OR SECTION THIRTEEN HUNDRED TEN OF THE SURROGATE'S COURT PROCEDURE ACT, NOR ANY POWER OF ATTORNEY, SHALL BE ACCEPTED FOR FILING OR RECORDING BY THE SURROGATE'S COURT OF A PARTIC-AMOUNT AT ISSUE IS IN EXCESS OF ONE THOUSAND ULAR COUNTY UNLESS THE
