- AN ACT to amend the racing, pari-mutuel wagering and breeding law, in relation to requiring transfer of all veterinary records of a claimed racehorse from the owner to the claimant within forty-eight hours from the time the claim is finalized

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Legislative Intent. The legislature hereby finds and 2 declares that it is in the best public policy interests of the state, 3 its businesses and its citizens to ensure that, to the greatest extent 4 possible, the letter and spirit of its thoroughbred racing regulations 5 aimed at protecting the health of New York's racehorses as well as the 6 jockeys, trainers, and owners, are enforced and enacted for any person 7 doing business in the New York state racing industry.

8 Measures to improve safety and health are necessary responses to the 9 "New York Task Force on Racehorse Health and Safety" established as a result of the fatalities of twenty-one racehorses at Aqueduct Race Track 10 during a four month period in 2011 and 2012. The task force stated that 11 because horses are regularly sold in claiming races and due to the lack 12 13 of transferring veterinary records at the time of sale, "horses are put increased risk of repeated, and potentially unnecessary invasive 14 at joint therapies." This increased risk was evidenced in the 15 official 16 report by the task force which noted the deaths of two racehorses could 17 have been prevented because "it is unlikely that the trainer was aware 18 of any medical treatments that may have occurred prior to his claiming 19 the horse. This may have compromised the trainer's ability to make informed decisions with regard to medication administrations." 20

Despite recommendations by the task force, little has been done to mitigate the problems even through the policy change is in the interest of the New York Racing Association, and the New York State Racing and Wagering Board. The policy change has also obtained wide-spread support from the American Association of Equine Practitioners, who stated in the

official report, "AAEP supports the position that when a horse is sold, 1 any known invasive surgery, disease, injury or congenital defect, which 2 is not apparent, should be disclosed to the intended buyer by the owner 3 4 and/or agent." This state of affairs places unnecessary danger on the racehorses and the jockeys of all the horses in claiming races across the state. This legislature further declares that it is in the best 5 6 7 interest of the state to adopt policies that promote the health and safety of racehorses through improved disclosure and sharing of veteri-8 9 narian records. 10 S 2. The racing, pari-mutuel wagering and breeding law is amended by 11 adding a new section 258 to read as follows: 12 TRANSFER OF VETERINARY RECORDS S 258. FOR CLAIMED RACEHORSES. 1. DEFINITIONS. AS USED IN THIS SECTION, THE FOLLOWING TERMS SHALL HAVE THE 13 14 FOLLOWING MEANINGS: 15 (A) "CLAIMING RACE" MEANS A RACE IN WHICH EVERY HORSE RUNNING IN SUCH 16 RACE MAY BE CLAIMED. 17 "CLAIMANT" MEANS A PERSON OR ENTITY WHO SUCCESSFULLY BECOMES THE (B) OWNER OF A HORSE IN A CLAIMING RACE. 18 19 (C) "OWNER" AS APPLIED TO THE RACING OF A HORSE MEANS, ANY MANAGING OWNER, A RACING OWNER, A PART OWNER, A LESSOR OR LESSEE AND MAY COMPRO-20 21 MISE ONE OR MORE PEOPLE IN A PARTNERSHIP OR ANY FORM OF COLLECTIVE 22 OWNERSHIP. 23 (D) "PRACTICING VETERINARIAN" MEANS A LICENSED VETERINARIAN WHO TREATS 24 ANY RACEHORSE. 25 (E) "RACEHORSE" THOROUGHBRED REGISTERED OR QUALIFIED FOR MEANS ANY 26 REGISTRATION BY THE JOCKEY CLUB. 27 (F) "VETERINARY RECORDS" MEANS ANY RECORD OF VETERINARY CARE ADMINIS-28 TERED BY A LICENSED, PRACTICING VETERINARIAN. 29 2. INORDER TO ENSURE THE PUBLIC'S CONFIDENCE AND CONTINUE THE HIGH DEGREE OF INTEGRITY AND SAFETY IN RACING AT 30 THE PARI-MUTUEL BETTING VETERINARY RECORDS FOR ALL CLAIMED RACEHORSES IN CLAIMING RACES 31 TRACKS, 32 MUST BE TRANSFERRED FROM THE OWNER OF THE RACEHORSE OR THE OWNER'S 33 AUTHORIZED AGENT TO THE CLAIMANT. THIS TRANSFER MUST BE COMPLETED WITHIN TIME THAT THE CLAIM IS FINALIZED. THE STATE 34 FORTY-EIGHT HOURS OF THE 35 RACING AND WAGERING BOARD SHALL PROMULGATE ANY RULES AND REGULATIONS IMPLEMENT THE PROVISIONS OF THIS SECTION, INCLUDING ANY 36 NECESSARY TO 37 VOIDABLE CLAIMS AND ADMINISTRATIVE PENALTIES NECESSARY. 38 S 3. This act shall take effect on the one hundred eightieth day after it shall have become a law; provided, however, that effective immediate-39 40 ly, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date are 41 42 authorized to be made on or before such effective date.
