## CONCURRENT RESOLUTION OF THE SENATE AND ASSEMBLY

proposing an amendment to section 2 of article 3 of the constitution, in relation to increasing the terms of office of members of the legislature to four years

- Section 1. Resolved (if the Assembly concur), That section 2 of article 3 of the constitution be amended to read as follows:
- S 2. The senate shall consist of fifty members, except as hereinafter provided. The senators [elected in the year one thousand eight hundred and ninety-five shall hold their offices for three years, and 5 shall be [chosen] ELECTED for TERMS OF two years; PROVIDED, THAT SENATORS ELECTED IN THE YEAR TWO THOUSAND SIXTEEN AND IN SUBSEQUENT 7 YEARS THEREAFTER SHALL HOLD THEIR OFFICES FOR FOUR YEARS; 9 FURTHER, THAT IN ALL LEGISLATIVE TERMS THAT COMMENCE IMMEDIATELY FOLLOW-10 ING A DECENNIAL CENSUS YEAR, THE TERM SHALL BE TWO YEARS. The assembly 11 shall consist of one hundred and fifty members. The assembly members 12 [elected in the year one thousand nine hundred and thirty-eight, and 13 their successors, ] shall be [chosen] ELECTED for TERMS OF two years; PROVIDED, THAT ASSEMBLY MEMBERS ELECTED IN THE YEAR TWO THOUSAND SIXTEEN 14 IN SUBSEQUENT YEARS THEREAFTER SHALL HOLD THEIR OFFICES FOR FOUR 15 16 YEARS; PROVIDED, FURTHER, THAT IN ALL LEGISLATIVE TERMS THAT COMMENCE 17 IMMEDIATELY FOLLOWING A DECENNIAL CENSUS YEAR, THE TERM SHALL BE TWO 18 YEARS.
- 19 S 2. Resolved (if the Assembly concur), That the provisions of the 20 foregoing amendments shall apply only to terms of office commencing

after such amendments shall have been adopted pursuant to section 1 of article 19 of the constitution.

S 3. Resolved (if the Assembly concur), That the foregoing amendments be referred to the first regular legislative session convening after the next succeeding general election of the members of the assembly, and, in conformity with section 1 of article 19 of the constitution, be published for three months previous to the time of such election.
