AN ACT to amend the penal law, in relation to establishing the crimes of unlawful publication of an intimate image of a minor in the first and second degrees

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The section heading and the opening paragraph of section
2 250.40 of the penal law, as added by chapter 69 of the laws of 2003, are
3 amended to read as follows:
4 Unlawful surveillance AND PUBLICATION; definitions.
5 The following definitions shall apply to sections 250.45, 250.50,
6 250.55 [and], 250.60, 250.70 AND 250.75 of this article:
7 S 2. The penal law is amended by adding two new sections 250.70 and
8 250.75 to read as follows:
9 S 250.70 UNLAWFUL PUBLICATION OF AN INTIMATE IMAGE OF A MINOR IN THE
10 SECOND DEGREE.
11 A PERSON IS GUILTY OF UNLAWFUL PUBLICATION OF AN INTIMATE IMAGE OF A
12 MINOR IN THE SECOND DEGREE WHEN, HE OR SHE INTENTIONALLY PUBLISHES AN
13 IMAGE OR IMAGES OF THE SEXUAL OR OTHER INTIMATE PARTS OF A MINOR UNDER
14 THE AGE OF SIXTEEN YEARS WITHOUT EXPLICIT CONSENT OF THE PARENT OR GUAR-
15 DIAN OF SUCH MINOR TO PUBLISH SUCH IMAGE.
16 UNLAWFUL PUBLICATION OF AN INTIMATE IMAGE OF A MINOR IN THE SECOND
17 DEGREE IS A CLASS B MISDEMEANOR.
18 S 250.75 UNLAWFUL PUBLICATION OF AN INTIMATE IMAGE OF A MINOR IN THE
19 FIRST DEGREE.
20 A PERSON IS GUILTY OF UNLAWFUL PUBLICATION OF AN INTIMATE IMAGE OF A
21 MINOR IN THE FIRST DEGREE WHEN HE OR SHE COMMITS THE CRIME OF UNLAWFUL
22 PUBLICATION OF AN INTIMATE IMAGE OF A MINOR IN THE SECOND DEGREE AND HAS
23 PREVIOUSLY BEEN CONVICTED WITHIN THE PAST TEN YEARS OF UNLAWFUL PUBLICA-
24 TION OF AN INTIMATE IMAGE OF A MINOR IN THE FIRST OR SECOND DEGREE.
25 UNLAWFUL PUBLICATION OF AN INTIMATE IMAGE OF A MINOR IN THE FIRST
26 DEGREE IS A CLASS A MISDEMEANOR.

1 S 3. Nothing in this act shall be construed to impose liability on an
2 interactive computer service for content provided by another person. The
3 term "interactive computer service" means any information service,
4 system, or access software provider that provides or enables computer
5 access by multiple users to a computer server, including specifically a
6 service or system that provides access to the Internet and such systems
7 operated or services offered by libraries or educational institutions.
8 S 4. This act shall take effect on the one hundred eightieth day after
9 it shall have become a law.
