AN ACT to amend the penal law, in relation to homicide by sale of an opiate controlled substance

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Section 220.00 of the penal law is amended by adding a new  
2     subdivision 21 to read as follows:

3     21. "OPIATE CONTROLLED SUBSTANCE" MEANS ANY SUBSTANCE LISTED IN SCHED-  
4     ULE I, II, III, IV OR V OF SECTION THIRTY-THREE HUNDRED SIX OF THE  
5     PUBLIC HEALTH LAW THAT IS CLASSIFIED AS EITHER AN OPIATE OR OPIUM DERIV-  
6     ATIVE UNDER SUCH LAW.

7     S 2. The penal law is amended by adding a new section 125.24 to read  
8     as follows:

9     S 125.24 HOMICIDE BY SALE OF AN OPIATE CONTROLLED SUBSTANCE.

10     A PERSON IS GUILTY OF HOMICIDE BY SALE OF AN OPIATE CONTROLLED  
11     SUBSTANCE WHEN ONE UNLAWFULLY TRANSPORTS BY IMPORTING INTO THE STATE OR  
12     TRANSPORTING WITHIN THE STATE FROM ONE COUNTY INTO ANOTHER, OR UNLAW-  
13     FULLY SELLS AS DEFINED BY SUBDIVISION ONE OF SECTION 220.00 OF THIS  
14     CHAPTER, AN OPIATE CONTROLLED SUBSTANCE AS DEFINED BY SUBDIVISION TWEN-  
15     TY-ONE OF SECTION 220.00 OF THIS CHAPTER, AND SUCH OPIATE CONTROLLED  
16     SUBSTANCE CAUSES THE DEATH OF ANOTHER.

17     IT SHALL BE A DEFENSE TO HOMICIDE BY SALE OF AN OPIATE CONTROLLED  
18     SUBSTANCE THAT THE DEFENDANT JOINTLY AND SIMULTANEOUSLY ACQUIRED AND  
19     POSSESSED SUCH OPIATE CONTROLLED SUBSTANCE FOR JOINT USE WITH THE  
20     DECEASED, WITH THE INTENT TO JOINTLY INJECT, INHALE OR OTHERWISE INGEST  
21     SUCH OPIATE CONTROLLED SUBSTANCE.

22     HOMICIDE BY SALE OF AN OPIATE CONTROLLED SUBSTANCE IS A CLASS A-I  
23     FELONY.

24     S 3. This act shall take effect on the ninetieth day after it shall  
25     have become a law.
