- AN ACT to amend the mental hygiene law, in relation to establishing the division of minority mental health within the office of mental health, and providing for its powers and duties

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Legislative intent. The legislature hereby finds 1 that 2 racial and ethnic minorities in America comprise a substantial and 3 vibrant segment of the United States population. According to the 2000 4 United States Census, minorities comprised the majority of the New York City population. Further, the legislature finds that nearly half of all 5 6 New York City households speak a language other than English at home, and that the "enormous shortage of trained bilingual and bicultural 7 counselors, therapists, psychiatrists and social workers, make it impos-8 9 sible, for many limited-English-proficient New Yorkers to obtain refer-10 rals and timely, appropriate mental health services" (New York State Assembly Standing Committee on Mental Health report, AN EVALUATION OF 11 THE DELIVERY OF MENTAL HYGIENE SERVICES IN NEW YORK STATE, 12 February 13 2005). Moreover, the legislature finds that the President's New Freedom 14 Commission on Mental Health also found that the mental health system in 15 the United States "has not kept pace with the diverse needs of racial and ethnic minorities. Misunderstanding and misinterpreting behaviors 16 have led to tragic consequences, including inappropriately placing 17 minorities in the criminal and juvenile justice systems." Consequently, 18 19 legislature finds that a division of minority mental health should the 20 be created to address the unique mental health needs of the racial and 21 ethnic minority citizens of the state.

52 53 54 55	(A) THERE IS HEREBY ESTABLISHED, WITHIN THE DIVISION, A MINORITY MENTAL HEALTH COUNCIL TO CONSIST OF THE COMMISSIONER AND FOURTEEN APPOINTED MEMBERS. THE COMMISSIONER SHALL SERVE AS THE CHAIR OF THE COUNCIL. THE APPOINTED MEMBERSHIP OF THE COUNCIL SHALL HAVE RELEVANT

EXPERIENCE RELATED TO THE PROVISION OR RECEIPT OF MINORITY SERVICES AND 1 2 SHALL BE REFLECTIVE OF THE DIVERSITY OF THE STATE'S POPULATION INCLUD-3 ING, BUT NOT LIMITED TO, THE VARIOUS MINORITY POPULATIONS THROUGHOUT THE 4 STATE.
