AN ACT to amend the penal law, in relation to assaults upon station cleaners and terminal cleaners

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 11 of section 120.05 of the penal law, as
2 amended by chapter 487 of the laws of 2015, is amended to read as
3 follows:
4 11. With intent to cause physical injury to a train operator, ticket
5 inspector, conductor, signalperson, bus operator [or], station agent,
6 STATION CLEANER OR TERMINAL CLEANER employed by any transit agency,
7 authority or company, public or private, whose operation is authorized
8 by New York state or any of its political subdivisions, a city marshal,
9 a school crossing guard appointed pursuant to section two hundred
10 eight-a of the general municipal law, a traffic enforcement officer,
11 traffic enforcement agent, prosecutor as defined in subdivision thirty-
12 one of section 1.20 of the criminal procedure law, sanitation enforce-
13 ment agent, New York city sanitation worker, registered nurse, licensed
14 practical nurse, emergency medical service paramedic, or emergency
15 medical service technician, he or she causes physical injury to such
16 train operator, ticket inspector, conductor, signalperson, bus operator
17 [or], station agent, STATION CLEANER OR TERMINAL CLEANER, city marshal,
18 school crossing guard appointed pursuant to section two hundred eight-a

50 S 3. This act shall take effect on the first of November next succeed-
51 ing the date upon which it shall have become a law; provided, however,
52 if chapter 472 of the laws of 2015 shall not have taken effect on or
53 before such date then section two of this act shall take effect on the
54 same date and in the same manner as such chapter of the laws of 2015,
55 takes effect.
