Introduced by M. of A. MAGEE, CROUCH, FINCH -- read once and referred to the Committee on Environmental Conservation

AN ACT to amend the environmental conservation law, in relation to providing for the lease of the Rogers environmental education center in the town of Sherburne, county of Chenango, to the Friends of Rogers Environmental Education Center, Inc., and providing for certain terms of such lease

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 3-0301 of the environmental conservation law is 2 amended by adding a new subdivision 6 to read as follows:

3 6. THE DEPARTMENT, BY AND THROUGH THE COMMISSIONER, SHALL, IN ADDITION 4 TO ANY OTHER PROVISION OF LAW AUTHORIZING THE LEASING OF PROPERTY UNDER 5 ITS JURISDICTION, LEASE THE LAND, AND THE BUILDINGS, STRUCTURES AND б IMPROVEMENTS THEREON, CONSTITUTING THE ROGERS ENVIRONMENTAL EDUCATION 7 THE TOWN OF SHERBURNE, COUNTY OF CHENANGO, TO THE FRIENDS OF CENTER IN 8 ROGERS ENVIRONMENTAL EDUCATION CENTER, INC., A NOT-FOR-PROFIT CORPO-9 RATION, FOR A TERM OF NOT LESS THAN FORTY YEARS FOR THE PURPOSE OF THE OPERATION OF SUCH CENTER TO PROMOTE THE UNDERSTANDING OF 10 ENVIRONMENTAL CONSERVATION. SUCH EXTENDED LEASE TERM SHALL BE FOR ASSURING THE LESSEE 11 OF ADEQUATE PROTECTION AGAINST LOSS OF INVESTMENTS 12 IN RENOVATIONS AND 13 IMPROVEMENTS TO, AND THE OPERATION AND MAINTENANCE OF THE ROGERS ENVI-RONMENTAL EDUCATION CENTER DURING THE TERM OF 14 THE LEASE. SUCH LEASE SHALL REQUIRE THE LESSEE TO OPERATE SUCH CENTER IN A MANNER THAT WILL 15 16 ENCOURAGE INVESTMENT BY THE PRIVATE SECTOR IN MAINTAINING AND OPERATING 17 ROGERS ENVIRONMENTAL EDUCATION CENTER FOR PUBLIC USE AND ENJOYMENT, THE 18 IN FURTHERANCE OF ENVIRONMENTAL EDUCATION AND PRESERVATION OF THE NATURAL RESOURCES OF SUCH CENTER. THE LESSEE SHALL HAVE SOLE DISCRETION 19 IN DETERMINING WHICH INVESTMENTS BY THE PRIVATE SECTOR, AND THE 20 PARTIES 21 INVESTMENTS SHALL BE ACCEPTED OR REJECTED. THE LEASE MAKING SUCH 22 REQUIRED BY THIS SUBDIVISION SHALL AUTHORIZE THE LESSEE IMPOSE то AND 23 COLLECT REASONABLE USE FEES FOR EVENTS, PROGRAMS AND ACTIVITIES 24 CONDUCTED BY IT UPON THE GROUNDS OF THE ROGERS ENVIRONMENTAL EDUCATION CENTER INCLUDING, BUT NOT LIMITED TO, SUCH EDUCATIONAL PROGRAMS, RECRE-25

ATIONAL ACTIVITIES, USES OF SUCH CENTER AND FUNDRAISING EVENTS AS SHALL 1 BE DETERMINED BY THE LESSEE IN ITS DISCRETION; PROVIDED, HOWEVER, THAT 2 ALL FEES AND REVENUE COLLECTED BY THE LESSEE SHALL BE USED EXCLUSIVELY 3 4 FOR THE OPERATION AND MAINTENANCE OF THE CENTER.
