AN ACT to amend the vehicle and traffic law, in relation to the issuance of distinctive plates for members of Kiwanis International

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new 2 section 404-x to read as follows:

- S 404-X. DISTINCTIVE PLATES FOR MEMBERS OF THE KIWANIS INTERNATIONAL.

 1. ANY MEMBER OF KIWANIS INTERNATIONAL RESIDING IN THIS STATE SHALL,
 UPON REQUEST, BE ISSUED A LICENSE PLATE BEARING THE WORDS "KIWANIS
 INTERNATIONAL". APPLICATION FOR SUCH LICENSE PLATE SHALL BE FILED WITH
 THE COMMISSIONER IN SUCH FORM AND DETAIL AS THE COMMISSIONER SHALL
 PRESCRIBE.
- 9 2. THE DISTINCTIVE PLATE AUTHORIZED IN SUBDIVISION ONE OF THIS SECTION 10 SHALL BE ISSUED UPON PROOF, SATISFACTORY TO THE COMMISSIONER, THAT THE 11 APPLICANT IS A MEMBER OF KIWANIS INTERNATIONAL.
- 3. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED 12 13 IN THE SAME MANNER AS OTHER NUMBER PLATES UPON PAYMENT OF THEREGULAR REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS ARTICLE; 14 15 PROVIDED, HOWEVER, THAT AN ADDITIONAL ANNUAL SERVICE CHARGE TWENTY-FIVE DOLLARS SHALL BE CHARGED FOR SUCH PLATE. SUCH SERVICE CHARGE 16 SHALL BE DEPOSITED PURSUANT TO THE PROVISIONS OF SECTION FOUR 17 18 THIS ARTICLE TO THE CREDIT OF THE DEPARTMENT OF MOTOR VEHI-19 CLES DISTINCTIVE PLATE DEVELOPMENT FUND ESTABLISHED ΒY SECTION 20 NINETY-FIVE-G OF THE STATE FINANCE LAW AND SHALL BE USED FOR THE DESIGN, 21 ADVERTISING AND DISTRIBUTION OF DISTINCTIVE LICENSE PLATES PRODUCTION, 22 IN ACCORDANCE WITH SUCH SECTION NINETY-FIVE-G.
- S 2. This act shall take effect on the one hundred eightieth day after it shall have become a law; provided further, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date are authorized and directed to be made and completed on or before such effective date.
