- AN ACT to amend the general municipal law, in relation to authorizing volunteer firefighters from other states to provide assistance to fire departments, companies and districts in this state

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 209-i of the general municipal law is amended by 2 adding a new subdivision 1-c to read as follows:

3 1-C. AN OUT-OF-STATE FIREFIGHTER WHO, BECAUSE OF A SECOND RESIDENCE OR 4 MILITARY SERVICE, IS REGULARLY IN AN AREA SERVED BY A VOLUNTEER FIRE 5 FIRE DEPARTMENT MAY VOLUNTEER THEIR SERVICES ON AN ON-GOING COMPANY OR 6 BASIS TO SUCH FIRE COMPANY OR FIRE DEPARTMENT FOR THE PURPOSE OF ASSIST-7 OR DEPARTMENT'S ING SUCH COMPANY GENERAL OR EMERGENCY AMBULANCE 8 PURPOSE OF ASSISTING SUCH FIRE COMPANY OR FIRE SERVICES, OR FOR THE 9 DEPARTMENT AT A FIRE OR OTHER EMERGENCY SCENE OR FOR THE PURPOSE OF TRAINING WITH SUCH FIRE COMPANY OR FIRE DEPARTMENT, PROVIDED THAT SUCH 10 11 COMPANY OR DEPARTMENT IS AUTHORIZED TO ACCEPT SUCH SERVICES ΒY THE BODY OF THE CITY OR THE VILLAGE, THE BOARD OF FIRE COMMIS-12 LEGISLATIVE SIONERS OR OTHER GOVERNING BOARD OF THE FIRE DISTRICT, OR THE TOWN BOARD 13 14 OF THE TOWN IN RELATION TO (A) THEFIRE COMPANIES SERVING TERRITORY 15 OUTSIDE VILLAGES AND FIRE DISTRICTS OR (B) A TOWN FIRE DEPARTMENT, AS 16 THE CASE MAY BE. UPON APPLICATION BY AN OUT-OF-STATE FIREFIGHTER, A FIRE 17 COMPANY OR FIRE DEPARTMENT SHALL DETERMINE WHETHER THEOUT-OF-STATE FIREFIGHTER MEETS THE MINIMUM CERTIFICATIONS FOR ACTIVE MEMBERS OF THEIR 18

COMPANY OR DEPARTMENT AND WHETHER THE OUT-OF-STATE FIRE-FIGHTER IS IN 1 2 GOOD STANDING WITH THE FIRE COMPANY OR DEPARTMENT IN WHICH THEY NORMALLY 3 SERVE. IF A VOLUNTEER FIRE COMPANY OR FIRE DEPARTMENT ACCEPTS THE 4 SERVICES OF AN OUT-OF-STATE FIREFIGHTER, SUCH FIREFIGHTER SHALL BE ENTI-5 TLED TO ALL POWERS, RIGHTS, PRIVILEGES AND IMMUNITIES GRANTED BY LAW TO 6 VOLUNTEER FIREFIGHTERS DURING THE TIME SUCH SERVICES ARE RENDERED, 7 PROVIDED, HOWEVER, SUCH FIREFIGHTER SHALL NOT BE ELIGIBLE TO PARTICIPATE IN A SERVICE AWARD PROGRAM AS AUTHORIZED BY ARTICLES ELEVEN-A AND 8 9 ELEVEN-AAAA OF THE GENERAL MUNICIPAL LAW NOR SHALL SUCH FIREFIGHTER BE 10 ELIGIBLE FOR COVERAGE UNDER SECTION ELEVEN-C OF THE VOLUNTEER FIREFIGHT-BENEFIT LAW RELATING TO DISEASES OF THE LUNG AND SECTION SIXTY-ONE ERS ' 11 OF THE VOLUNTEER FIREFIGHTERS' BENEFIT LAW RELATING TO DISEASE OR 12 MALFUNCTION OF HEART OR CORONARY ARTERIES AND ANY OTHER PRESUMPTIVE 13 14 COVERAGE FOR IMPAIRMENT OF HEALTH OR DEATH. UPON ACCEPTANCE OF AN 15 OUT-OF-STATE FIREFIGHTER TO A FIRE COMPANY OR FIRE DEPARTMENT, SUCH COMPANY OR DEPARTMENT SHALL PROVIDE TO THE APPLICANT, AND THE APPLICANT 16 17 SHALL ACKNOWLEDGE RECEIPT OF, THE FOLLOWING WRITTEN STATEMENT: "IF A VOLUNTEER FIRE COMPANY OR FIRE DEPARTMENT ACCEPTS THE SERVICES OF AN 18 19 OUT-OF-STATE FIREFIGHTER, SUCH FIREFIGHTER SHALL BE ENTITLED TO ALL POWERS, RIGHTS, PRIVILEGES AND IMMUNITIES GRANTED BY LAW TO VOLUNTEER 20 FIREFIGHTERS DURING THE TIME SUCH SERVICES ARE RENDERED, PROVIDED, 21 22 HOWEVER, SUCH FIREFIGHTER SHALL NOT BE ELIGIBLE TO PARTICIPATE IN A SERVICE AWARD PROGRAM AS AUTHORIZED BY ARTICLES 11-A AND 11-AAAA OF THE 23 GENERAL MUNICIPAL LAW, NOR SHALL SUCH FIREFIGHTERS BE ELIGIBLE FOR 24 25 COVERAGE UNDER SECTION ELEVEN-C OF THE VOLUNTEER FIREFIGHTERS' BENEFIT 26 LAW, RELATING TO DISEASES OF THE LUNG, AND SECTION 61 OF THE VOLUNTEER FIREFIGHTERS' BENEFIT LAW, RELATING TO DISEASE OR MALFUNCTION OF HEART 27 28 OR CORONARY ARTERIES, AND ANY OTHER PRESUMPTIVE COVERAGE FOR IMPAIRMENT 29 OF HEALTH OR DEATH."

30 S 2. This act shall take effect immediately.
