AN ACT to amend the penal law and the criminal procedure law, relation to repeat offenders of driving accidents; to amend the vehicle and traffic law, in relation to drugged driving; and to amend the criminal procedure law, in relation to speedy trials and certain vehicular crimes

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph (a) of subdivision 1 of section 70.06 of the penal law, as amended by chapter 410 of the laws of 1979, is amended to read as follows:

- (a) A second felony offender is a person, other than a second violent felony offender as defined in section 70.04, who stands convicted of a felony defined in this chapter OR IN THE VEHICLE AND TRAFFIC LAW, other than a class A-I felony, after having previously been subjected to one or more predicate felony convictions as defined in paragraph (b) of this subdivision.
- 10 2. Paragraphs (b) and (c) of subdivision 1 of section 160.10 of the criminal procedure law, as amended by chapter 762 of the laws of 1971, 11 are amended to read as follows: 12
- (b) A misdemeanor defined in the penal law OR THE VEHICLE AND TRAFFIC 14 LAW; or
- 15 (c) A misdemeanor defined outside the penal law OR THE VEHICLE AND 16 TRAFFIC LAW which would constitute a felony if such person had a previous judgment of conviction for a crime; or 17
- S 3. Section 114-a of the vehicle and traffic law, as added by chapter 18 163 of the laws of 1973, is amended to read as follows: 19
- 20 S 114-a. Drug. The term "drug" when used in this chapter, means [and 21 includes any substance listed in section thirty-three hundred six of the 22 public health law | ANY DRUG OR IMPAIRING SUBSTANCE.

1 S 4. Paragraph (e) of subdivision 2 of section 1193 of the vehicle and 2 traffic law is amended by adding a new subparagraph 8 to read as 3 follows:

- (8) SUSPENSION PENDING PROSECUTION; DRUG IMPAIRMENT. EXCEPT AS PROVIDED IN CLAUSE A-1 OF SUBPARAGRAPH SEVEN OF THIS PARAGRAPH, A COURT SHALL SUSPEND A DRIVER'S LICENSE, PENDING PROSECUTION, OF ANY PERSON CHARGED WITH A VIOLATION OF SUBDIVISION FOUR OR FOUR-A OF SECTION ELEVEN HUNDRED NINETY-TWO OF THIS ARTICLE WHO, AT THE TIME OF ARREST, IS ALLEGED TO HAVE BEEN ABILITY IMPAIRED BY DRUGS.
- 10 S 5. Paragraph (a) of subdivision 3 of section 30.30 of the criminal 11 procedure law, as amended by chapter 93 of the laws of 2006, is amended 12 to read as follows:
- 13 (a) Subdivisions one and two do not apply to a criminal action wherein 14 the defendant is accused of an offense defined in sections 125.10, 125.12, 125.13, 125.14, 125.15, 125.20, 125.25, 125.26 and 125.27 of the penal law.
- 17 S 6. This act shall take effect immediately.
