AN ACT to amend the vehicle and traffic law, in relation to photo speed violation monitoring systems in school speed zones in the city of New York; and to repeal certain provisions of such law relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph 1 of subdivision (a) of section 1180-b of the 2 vehicle and traffic law, as amended by chapter 43 of the laws of 2014, 3 is REPEALED.

4 S 2. Paragraph 1 of subdivision (a) of section 1180-b of the vehicle 5 and traffic law, as added by chapter 189 of the laws of 2013, is amended 6 to read as follows:

7 1. Notwithstanding any other provision of law, the city of New York is 8 hereby authorized to establish a demonstration program imposing monetary 9 liability on the owner of a vehicle for failure of an operator thereof 10 to comply with posted maximum speed limits in a school speed zone within SUCH city (i) when a school speed limit is in effect as provided 11 [the] in paragraphs one and two of subdivision (c) of section eleven hundred 12 13 eighty of this article or (ii) when other speed limits are in effect as provided in subdivision (b), (d), (f) or (g) of section eleven hundred 14 eighty of this article [during the following times: (A)] on school days 15 [during school hours and one hour before and one hour after the school 16 and (B) a period during student activities at the school and up to 17 day, 18 thirty minutes immediately before and up to thirty minutes immediately after such student activities] BETWEEN THE HOURS OF SEVEN O'CLOCK A.M. 19 20 AND SEVEN O'CLOCK P.M. Such demonstration program shall empower the 21 city OF NEW YORK to install photo speed violation monitoring systems within no more than [twenty] TWO HUNDRED school speed zones within [the] 22 SUCH city at any one time and to operate such systems within such zones 23 24 (iii) when a school speed limit is in effect as provided in paragraphs 25 one and two of subdivision (c) of section eleven hundred eighty of this 26 (iv) when other speed limits are in effect as provided in article or subdivision (b), (d), (f) or (g) of section eleven hundred eighty of 27

this article [during the following times: (A)] on school days [during 1 2 school hours and one hour before and one hour after the school day, and a period during student activities at the school and up to thirty 3 (B) 4 minutes immediately before and up to thirty minutes immediately after such student activities] BETWEEN THE HOURS OF SEVEN O'CLOCK A.M. 5 AND 6 SEVEN O'CLOCK P.M. In selecting a school speed zone in which to install operate a photo speed violation monitoring system, the city OF NEW 7 and 8 YORK shall consider criteria including, but not limited to, the speed 9 data, crash history, and the roadway geometry applicable to such school 10 speed zone. A PHOTO SPEED VIOLATION MONITORING SYSTEM SHALL NOT ΒE 11 INSTALLED ON A CONTROLLED-ACCESS HIGHWAY EXIT RAMP OR WITHIN THREE HUNDRED FEET ALONG A HIGHWAY THAT CONTINUES FROM THE 12 END OF A CONT-13 ROLLED-ACCESS HIGHWAY EXIT RAMP.

14 S 3. Paragraph 2 of subdivision (a) of section 1180-b of the vehicle 15 and traffic law, as added by chapter 189 of the laws of 2013, is amended 16 to read as follows:

2. No photo speed violation monitoring system shall be used in a 17 school speed zone unless (i) on the day it is to be used it has success-18 fully passed a self-test of its functions; and (ii) it has undergone an annual calibration check performed pursuant to paragraph four of this 19 20 21 subdivision. The city [may] SHALL install signs giving notice that a 22 photo speed violation monitoring system is in use to be mounted on advance warning signs notifying motor vehicle operators of such upcoming 23 school speed zone and/or on speed limit signs applicable within OR 24 25 APPROACHING such school speed zone, PROVIDED THAT SUCH SPEED LIMIT SIGNS SHALL BE NO MORE THAN THREE HUNDRED FEET FROM SUCH SCHOOL SPEED ZONE, in 26 27 conformance with standards established in the MUTCD.

28 S 4. Paragraph 4 of subdivision (c) of section 1180-b of the vehicle 29 and traffic law, as added by chapter 189 of the laws of 2013, is amended 30 to read as follows:

31 4. "school speed zone" shall mean a RADIAL distance not to exceed one 32 thousand three hundred twenty feet [on a highway passing] FROM a school 33 building, entrance or exit [of a school abutting on the highway].

34 S 5. Subdivision (j) of section 1180-b of the vehicle and traffic law 35 is REPEALED and subdivisions (k), (l), (m), (n) and (o) are relettered 36 subdivisions (j), (k), (l), (m) and (n), respectively.

37 S 6. Paragraphs 2 and 3 of subdivision (j) of section 1180-b of the 38 vehicle and traffic law, as added by chapter 189 of the laws of 2013 and 39 such subdivision as relettered by section five of this act, are amended 40 to read as follows:

41 2. Failure to comply with subparagraph (ii) of paragraph [(a)] ONE of 42 this subdivision shall render the owner liable for the penalty 43 prescribed in this section.

3. Where the lessor complies with the provisions of paragraph [(a)] ONE of this subdivision, the lessee of such vehicle on the date of such violation shall be deemed to be the owner of such vehicle for purposes of this section, shall be subject to liability for such violation pursuant to this section and shall be sent a notice of liability pursuant to subdivision [nine] (G) of this section.

50 S 7. This act shall take effect immediately; provided that the amend-51 ments to section 1180-b of the vehicle and traffic law made by this act 52 shall not affect the repeal of such section and shall be deemed repealed 53 therewith.
