AN ACT to amend the social services law, in relation to the state reimbursement of county payments for certain document management software designed specifically for the child welfare industry

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 368-a of the social services law
2 is amended by adding a new paragraph (aa) to read as follows:
3 (AA) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE FULL AMOUNT
4 EXPENDED BY THE LOCAL SOCIAL SERVICES DISTRICT TO PROVIDE SERVICES TO
5 CHILDREN WHO ARE THE SUBJECT OF ABUSE, NEGLECT OR OTHER FORMS OF
6 MALTREATMENT VIA THE USE OF DOCUMENT MANAGEMENT SOFTWARE DESIGNED
7 SPECIFICALLY FOR THE CHILD WELFARE INDUSTRY. DOCUMENT MANAGEMENT SOFTWARE SHALL BE REIMBURSED BY THE STATE IF THE COUNTY HAS PREVIOUSLY
8 PURCHASED OR INTENDS TO PURCHASE SUCH SOFTWARE. FOR THE PURPOSES OF THIS
9 PARAGRAPH, "DOCUMENT MANAGEMENT SOFTWARE" SHALL MEAN A DATABASE APPLICATION THAT UTILIZES ADVANCED DOCUMENT CAPTURE, STORAGE, AND RETRIEVAL
10 TECHNOLOGY TO ESTABLISH A PAPERLESS ENVIRONMENT BOTH WITHIN THE AGENCY
11 AND IN THE FIELD. ANY COUNTY THAT HAS PREVIOUSLY PURCHASED SUCH SOFTWARE
12 MUST SUPPLY ADEQUATE DOCUMENTATION, INCLUDING ANY RECEIPTS, THAT DETAILS
13 SUCH PURCHASE. THE STATE SHALL DISBURSE GRANTS, WHEN APPLICABLE, FROM
14 THE GENERAL FUND FOR THIS PURPOSE.
15 S 2. This act shall take effect immediately.
