AN ACT to amend the retirement and social security law, in relation to the limitation for retired police officers employed as school resource officers

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 3 of section 212 of the retirement and social
2 security law, as added by section 1 of part Y of chapter 55 of the laws
3 of 2013, is amended to read as follows:
4 3. Notwithstanding the provisions of subdivisions one and two of this
5 section, [the commissioner of education may determine, pursuant to
6 section two hundred eleven of this article, that] such earnings limita-
7 tions shall not apply to a retired police officer employed by a school
8 district IN EITHER THE CLASSIFIED OR UNCLASSIFIED SERVICE as a school
9 resource officer, SCHOOL SAFETY OFFICER, SCHOOL SECURITY OFFICER OR ANY
10 OTHER SUBSTANTIALLY SIMILAR POSITION OR OFFICE THAT IS DESIGNED TO
11 PROVIDE SAFETY AND/OR SECURITY ON SCHOOL GROUNDS, PROVIDED THAT SUCH
12 RETIRED POLICE OFFICER IS DULY QUALIFIED, COMPETENT AND PHYSICALLY FIT
13 FOR PERFORMANCE OF THE DUTIES OF THE POSITION IN WHICH HE OR SHE IS TO
14 BE EMPLOYED AS DETERMINED BY THE SCHOOL DISTRICT AND IS PROPERLY CERTI-
15 FIED WHERE SUCH CERTIFICATION IS REQUIRED.
16 S 2. This act shall take effect immediately.
17 FISCAL NOTE. -- Pursuant to Legislative Law, Section 50:
18 This bill will allow retired police officers to be employed by a
19 school district as a school safety officer, school security officer or

1 any other substantially similar position and continue to receive their
2 full retirement benefit. Currently, this privilege is only allowed to
3 retired police officers who are employed as a school resource officer.

4 If this bill is enacted, insofar as it will affect the New York State
5 and Local Police and Fire retirement System, we expect few retirees to
6 be affected. There would be negligible additional annual costs.

7 Summary of relevant resources:

8 The membership data used in measuring the impact of the proposed
9 change was the same as that used in the March 31, 2015 actuarial valu-
10 ation. Distributions and other statistics can be found in the 2015
11 Report of the Actuary and the 2015 Comprehensive Annual Financial
12 Report.

13 The actuarial assumptions and methods used are described in the 2015
14 Annual Report to the Comptroller on Actuarial Assumptions, and the Codes
15 Rules and Regulations of the State of New York: Audit and Control.

18 Supplementary Information.
