AN ACT to amend the tax law, in relation to providing a tax check off box on personal income tax return forms for the life pass it on trust fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Part 2 of article 22 of the tax law is amended by adding a 2 new section 630-e to read as follows:

- GIFT FOR ORGAN AND TISSUE DONATION OUTREACH AND RESEARCH. EFFECTIVE FOR ANY TAX YEAR COMMENCING ON OR AFTER JANUARY FIRST, THOUSAND SEVENTEEN, AN INDIVIDUAL IN ANY TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO THE LIFE PASS IT ON TRUST FUND. THE CONTRIBUTION SHALL BE IN ANY WHOLE DOLLAR AMOUNT AND SHALL NOT REDUCE THE AMOUNT OF STATE TAX INDIVIDUAL. THE COMMISSIONER SHALL INCLUDE SPACE ON THE SUCH PERSONAL INCOME TAX RETURN TO ENABLE A TAXPAYER TO MAKE SUCH CONTRIB-UTION. NOTWITHSTANDING ANY OTHER PROVISION OF LAW ALL REVENUES COLLECTED TO THIS SECTION SHALL BE CREDITED TO THE LIFE PASS IT ON TRUST PURSUANT FUND AND USED ONLY FOR THOSE PURPOSES ENUMERATED ΙN SECTION NINETY-FIVE-D OF THE STATE FINANCE LAW, AS ADDED BY CHAPTER FOUR HUNDRED FIFTEEN OF THE LAWS OF TWO THOUSAND THREE.
- 2. This act shall take effect on the first of January next succeeding the date on which it shall have become a law and shall apply to 16 taxable years beginning on or after such date, provided, however, that 17 effective immediately, all actions and procedures with respect to the proposed adoption, amendment, suspension or repeal of any rule or regulation necessary for the timely implementation of this act are directed and authorized to be made and completed on or before such effective 20 21 22 date.
