- AN ACT to amend the insurance law, in relation to requiring policies and contracts of insurance providing hospital, surgical, or medical care coverage to include coverage for human leukocyte antigen testing

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subsection (i) of section 3216 of the insurance law is 2 amended by adding a new paragraph 33 to read as follows:

3 (33) EVERY POLICY WHICH PROVIDES HOSPITAL, SURGICAL, OR MEDICAL CARE 4 COVERAGE OR PROVIDES REIMBURSEMENT FOR LABORATORY TESTS OR REIMBURSEMENT 5 FOR DIAGNOSTIC X-RAY SERVICES SHALL PROVIDE COVERAGE FOR HUMAN LEUKOCYTE 6 ANTIGEN TESTING, ALSO REFERRED TO AS HISTOCOMPATIBLE LOCUS ANTIGEN TEST-7 ING, FOR A, B, AND DR ANTIGENS FOR UTILIZATION IN TISSUE TYPING FOR BONE 8 MARROW TESTING.

9 S 2. Subsection (1) of section 3221 of the insurance law is amended by 10 adding a new paragraph 19 to read as follows:

11 (19) EVERY GROUP OR BLANKET POLICY DELIVERED OR ISSUED FOR DELIVERY IN THIS STATE WHICH PROVIDES HOSPITAL, SURGICAL, OR MEDICAL 12 CARE COVERAGE 13 SHALL PROVIDE COVERAGE FOR HUMAN LEUKOCYTE ANTIGEN TESTING, ALSO REFERRED TO AS HISTOCOMPATIBLE LOCUS ANTIGEN TESTING, FOR A, B, 14 AND DR 15 ANTIGENS FOR UTILIZATION IN TISSUE TYPING FOR BONE MARROW TESTING, EXCEPT THAT THIS PROVISION SHALL NOT APPLY A POLICY 16 то WHICH COVERS EMPLOYED IN MORE THAN ONE STATE OR THE BENEFIT STRUCTURE OF 17 PERSONS 18 WHICH WAS THE SUBJECT OF COLLECTIVE BARGAINING AFFECTING PERSONS WHO ARE 19 EMPLOYED IN MORE THAN ONE STATE.

1 S 3. Section 4303 of the insurance law is amended by adding a new 2 subsection (qq) to read as follows:

3 (QQ) A MEDICAL EXPENSE INDEMNITY CORPORATION, A HOSPITAL SERVICE 4 CORPORATION OR A HEALTH SERVICE CORPORATION WHICH PROVIDES COVERAGE FOR 5 SURGICAL, OR MEDICAL CARE SHALL PROVIDE COVERAGE FOR HUMAN HOSPITAL, LEUKOCYTE ANTIGEN TESTING, ALSO REFERRED TO AS HISTOCOMPATIBLE 6 LOCUS 7 ANTIGEN TESTING, FOR A, B, AND DR ANTIGENS FOR UTILIZATION IN TISSUE TYPING FOR BONE MARROW TESTING, EXCEPT THAT THIS PROVISION SHALL NOT 8 9 APPLY TO A CONTRACT WHICH COVERS PERSONS EMPLOYED IN MORE THAN ONE STATE 10 OR THE BENEFIT STRUCTURE OF WHICH WAS THE SUBJECT OF COLLECTIVE BARGAIN-ING AFFECTING PERSONS WHO ARE EMPLOYED IN MORE THAN ONE STATE. 11

This act shall take effect on the first of January next succeed-12 S 4. ing the date on which it shall have become a law and shall apply to all 13 14 policies and contracts issued, renewed, modified, altered, or amended on 15 or after such effective date. Effective immediately any rules or regulations necessary for the implementation of this act on its effective 16 date shall be promulgated, and any other measures necessary for the 17 implementation of this act on its effective date shall be taken, on or 18 19 before such effective date.
