AN ACT to amend the penal law, in relation to creating the crime of tampering with electronic monitoring equipment

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The penal law is amended by adding two new sections 145.75 and 145.80 to read as follows:

- S 145.75 TAMPERING WITH ELECTRONIC MONITORING EQUIPMENT IN THE SECOND DEGREE.
- 1. FOR PURPOSES OF THIS SECTION, "ELECTRONIC MONITORING EQUIPMENT" MEANS AN INSTRUMENT OR DEVICE UTILIZED IN ACCORDANCE WITH SUBDIVISION FOUR OF SECTION 65.10 OF THIS CHAPTER.
- 2. A PERSON IS GUILTY OF TAMPERING WITH ELECTRONIC MONITORING MENT IN THE SECOND DEGREE WHEN, HAVING NO RIGHT TO DO SO NOR ANY REASON-ABLE GROUND TO BELIEVE THAT HE OR SHE HAS SUCH RIGHT, HE OR SHE TAMPERS WITH ELECTRONIC MONITORING EQUIPMENT, OR DAMAGES OR OTHERWISE SUCH ELECTRONIC MONITORING EQUIPMENT IN AN EFFORT TO INTERFERE WITH ANY SIGNAL, IMPULSE OR DATA BEING TRANSMITTED BY SUCH ELECTRONIC MONITORING EOUIPMENT.
- TAMPERING WITH ELECTRONIC MONITORING EQUIPMENT IN THE SECOND DEGREE IS A CLASS A MISDEMEANOR.
- 17 S 145.80 TAMPERING WITH ELECTRONIC MONITORING EQUIPMENT IN THE FIRST 18 DEGREE.
- 1. A PERSON IS GUILTY OF TAMPERING WITH ELECTRONIC MONITORING FIRST DEGREE WHEN, AS PART OF COMMITTING TAMPERING WITH THEELECTRONIC MONITORING EQUIPMENT IN THE SECOND DEGREE AS DEFINED 21 145.75 OF THIS ARTICLE, THE PERSON ALSO COMMITS A CRIME THAT IS 22 CLASSIFIED AS A CLASS A OR CLASS B FELONY. 23
- 24 2. WHEN A PERSON IS CONVICTED OF TAMPERING WITH ELECTRONIC MONITORING 25 IN FIRST DEGREE, THE COURT SHALL IMPOSE A SENTENCE FOR EOUIPMENT THE
